To properly review your application, we must have all required documents by April 3<sup>rd</sup> for fall semester admissions. However, it is to your advantage to fully complete and submit your application as early as possible. Applications will be evaluated by the Human Service Department Graduate Admissions Committee in the order they are received.

Please note that 9 credit hours per semester is considered full time. Students may select to complete the program on a part-time basis (less than 9 hours). The program is offered completely online.

The Master of Arts in Human Services, Addiction Counseling emphasis is approved by the Kansas Behavioral Sciences Regulatory Board (BSRB) to provide the educational curriculum required to become a Licensed Clinical Addiction Counselor (LCAC).

#### PROGRAM DESCRIPTION

For the professional currently employed in the field, advanced knowledge and skills acquired in this MA program can enhance opportunities for career advancement. The degree program is also designed to prepare the graduate for licensure as a Licensed Clinical Addiction Counselor (LCAC) with the Behavioral Sciences Regulatory Board (BSRB) in Kansas. In addition, the MA in Human Services degree program helps to prepare students for teaching positions in community colleges and for additional graduate study. Course work emphasizes the application of theory and research to the delivery of human services with an emphasis in addiction counseling.

Course scheduling and delivery methods are flexible and designed to meet the scheduling needs of students, including online courses and short courses such as weekend workshops.

#### I. ADMISSION

#### A. Entrance Requirements:

Admission to the MA in Human Services will be based on a review of application materials. A committee of faculty from the Department of Human Services will review application materials and make recommendations regarding admission to the program. Students applying for admission to the Master's program will submit a completed application; copy of undergraduate (and graduate, when applicable) transcript(s); three letters of recommendation from instructors and/or professionals in the field; and a written essay describing the student's intent and goals in pursuing the Master's degree. Minimum standard for admission to the Master's program is the completion of a Bachelor's degree in Human Services or a related field (e.g., Social Work, Psychology, Nursing, etc.) from an accredited institution of higher education with an overall GPA of 3.0 (on a 4.0 scale) over the last two years (60 credits) of university coursework. Applicants to the Master's program must already be licensed addiction counselors or must have equivalent education or experience. Students should be aware that the Kansas Behavioral Sciences Regulatory Board requires that applicants for licensure as a Licensed Clinical Addiction Counselor (LCAC) must meet, in addition to the required graduate-level coursework, all the requirements for licensure as an addiction counselor (LAC). The LAC requires a Bachelor's degree in a helping profession, 33 hours of coursework in addiction counseling, and a passing score on a national examination. Students wanting clarification on BSRB requirements should contact the BSRB directly.

Continuous full-time enrollment in the MA program is expected. Continuous enrollment requires satisfactory completion of at least three graduate courses (9 credit hours) in each of the fall and spring semesters with at least a 3.0 GPA per semester. If the student discontinues enrollment for two semesters or more, readmission is required. Should readmission be granted, it will be based on the requirements and regulations effective at the time of readmission. If a student drops out of sequence from his/her cohort due to discontinuing enrollment for a semester or two, the program will take longer to complete due to the sequential nature of course offerings.

#### **B.** General Requirements for Admission:

The admissions process is straightforward. Students submit the requested application materials by the deadline. Completed application packets are then reviewed by the Human Services Department Graduate Admissions Committee. Admission to the program is selective. The Department of Human Services can, and sometimes will, deny admission of applicants. This indicates that the applicant either lacks the necessary prerequisites or, in the opinion of the faculty, lacks the skills needed for successful completion of the degree program at the present time.

#### **Application Steps:**

- Applicants must have a copy of the <u>official</u> transcript sent directly to the Human Services Department from the institution where the credit was granted to show that the applicant has earned a Bachelor's degree from a four-year accredited college or university. Washburn graduates are not required to submit transcripts, but a Bachelor's Degree must be posted on their transcript before they will be considered for admission to the MA in Human Services program. If the applicant has graduate credit that they want to have considered for possible course substitutions, the applicant must also have any official graduate transcripts sent directly to the Human Services Department from the institution where the credit was granted. This step is not required of students who received graduate credit from Washburn.
- Applicants must complete and submit an Application for Formal
   Admission to Washburn University. This step is in addition to
   completing the Department's application packet. To fill out a

   required to fulfill all university graduate admissions requirements.

### Please note that acceptance to Washburn University *does not* guarantee admission into the MA Program.

 Applicants must submit a completed application form (attached to the end of this document) to the Human Services Department. This form requires applicants to write an essay explaining (a) personal philosophy of human services with special consideration to the area of addiction/recovery services and (b) reasons for entering the program.

- 4. Applicants must submit three reference forms from persons who are in a position to attest to the applicant's academic abilities and potential for graduate study, such as former instructors, internship supervisors, and work supervisors. References from former professors are welcomed, but may not be from the Human Services Department Chairperson or members of the Admissions Committee. The reference forms are included at the end of this application packet and must be submitted in sealed envelopes, with the signature of the person completing the reference across the seal. If you are seeking to transfer any course credits from another graduate program, please see the section on transfer credits regarding reference requirements.
- Applicants must complete, sign and submit the Student Background History
   Attestation along with the application form attached to the end of this
   document.

**Note:** Acceptance is <u>not</u> automatic. To become admitted to the MA program, the applicant must receive the recommendation of the Human Services Graduate Admissions Committee and approval of the Department Chair.

#### D. Notification

When a decision has been made regarding your application for study in the Master of Arts in Human Services with an emphasis in Addiction Counseling, you will receive a mailed letter from the Human Services Department which indicates your admission status. If admitted, you will be instructed to contact the department for advising purposes. NOTE: Notification from the Washburn University Admissions Office that all transcripts have been received, and that you have been admitted to Washburn University does <u>not</u> mean that you have been admitted to the Masters of Arts in Human Services program.

#### E. Transfer of Academic Credits

Students who are admitted to the MA Program may request to transfer a maximum of 9 semester hours of relevant graduate course work from another accredited university or Washburn University department. These will be considered on a case-by-case basis. The applicant must have received a grade of "B" or better in the course(s) being considered for transfer. If an applicant wishes to request transfer of graduate credit, one of the required reference letters must be from the director or department chair of the program from which credit is requested. If credit is requested for a practicum, one of the required reference letters must be from the practicum site supervisor. Washburn University is not able to guarantee that the transfer credits it accepts for its MA in Human Services program will be accepted by the Kansas BSRB for the LCAC, as the BSRB is its

own separate entity with its own policies and procedures. Students who have questions about whether transfer courses will count for licensure purposes should contact the BSRB directly.

Applicants should be aware that the transfer of credit could impact their eligibility for financial aid if they drop below full-time status in a given semester. Please contact the financial aid office directly for more information.

#### F. Life/Work Experience

The Washburn University Master of Arts in Human Services Program does not award college credit for life/work experiences.

#### II. TUITION

Tuition and fees are established by the Board of Regents and are subject to change at any time. All payments are made to the University Business Office. The tuition charge is applicable to all terms of work such as regular semester, evening program, etc., whether taken for credit or as an auditor. Information regarding tuition, student activity fees, parking, etc., can be found in the Washburn University Catalog.

#### III. ADVISING AND REGISTRATION

Upon admission to the Master of Arts in Human Services program, students will be advised by Human Services department faculty, who will assist students with selecting and scheduling courses.

Students must contact a Human Services graduate advisor at least once each semester prior to enrolling in the next semester. In cooperation with the advisor, students are expected to complete a plan of study as soon as possible after entering the program. Faculty members usually restrict themselves to advising you about course work and career objectives.

NOTE: Graduate students in the Human Services Department are not permitted to enroll in any undergraduate course work without written permission from their Human Services Department faculty advisor. Students who violate this rule may be administratively withdrawn.

All students are advised to take advantage of advanced registration for enrollment in courses. Advanced registration gives you an opportunity to review your overall plan for graduation with a faculty member while you have time to reflect and to plan. Students who want to take short-term classes (weekend classes) should pre-register at least 5 weeks before the semester begins so that they can receive and complete their reading assignments in a timely manner.

#### IV. DEGREE REQUIREMENTS

All students are required to maintain at least a "B" (3.0) grade point average in their

coursework per semester. Moreover, students are allowed only two letter grades of "C" during their graduate studies. Students who receive a letter grade below "C" will be administratively withdrawn from the program.

#### V. **DEADLINES**

A. Receipt of applications for admission: To be considered for admission in the fall semester, **all application materials must be received by March 1**<sup>st</sup>. The MA Program has one *application for admission* cycle at this time. If accepted, you will start in the Fall Term which begins in August. The MA Program only accepts new admissions once a year, and the program takes two years to complete.

B. There are several deadlines that must be met in regards to graduation. It is the student's responsibility to see that all forms are filed and all deadlines are met. Students may obtain a copy of graduation deadlines for the semester in which they will graduate from the University Registrar's Office. Students must regularly check their Washburn email for important announcements from the university.

#### VIII. COURSEWORK

The MA in Human Services degree program is a two (2) year program requiring a minimum of 36 credit hours of coursework. Of the 36 required credit hours, 30 credit hours are required coursework and 6 credit hours may be selected from electives. Students seeking licensure with the Kansas BSRB as Licensed Clinical Addiction Counselors must take the courses marked with an asterisk on the following lists of required and elective coursework.

**Required coursework**: The required coursework of 30 credit hours includes:

- 3. \*HS 605 Advanced Methods of Group Counseling
- 4. \*HS 610 Professional Ethics and Practice

- 6. \*HS 635 Diagnosis of Substance Use Disorders
- 7. \*HS 640 Supervised Practicum I
- 8. \*HS 641 Supervised Practicum II
- 9. HS 660 Clinical Supervision
- 10. \*HS 695 Applied Research

**<u>Elective coursework</u>**: The electives from which students must take 6 credit hours include:

- 1. \*HS 620 Integrative Approaches and Treatment of Dual Disorders
- 2. \*HS 625 Addiction and Recovery Services
- 3. HS 630 Lifespan Development
- 4. HS 665 Integrative Residential Experience-Special Topic Seminar
- 5. HS 679 Narrative Practices

Note: Admission to the MA Program does not guarantee acceptance into the practica. A separate application process is necessary, along with approval by a practicum site

#### IX. KANSAS ADDICTION COUNSELOR LICENSURE INFORMATION

Students who wish to become a licensed clinical addictions counselor (LCAC) in Kansas will need to have a minimum of 300 client contact hours across a minimum of six credit hours of practicum course work (i.e., a minimum of two practica; at Washburn, these are HS 640 and 641). In addition, the practica must include one in ten hours of clinical supervision. Supervision is to be provided by Washburn faculty and agency supervisors, at least one of whom shall be licensed at the clinical level (e.g., LCAC, LSCSW, LCPC). Applicants for the LCAC in Kansas must pass a national examination and complete a clinical supervision training plan that includes the following:

- 4,000 hours of supervised professional experience including at least 1500 hours of direct client contact conducting substance abuse assessments and treatment;
- Not less than 150 hours of clinical supervision, including not less than 50 hours of person-to-person individual supervision, integrating diagnosis and treatment of substance use disorders with the use of the Diagnostic and Statistical Manual of Mental Disorders of the American Psychiatric Association.

Note: Students from out of state who wish to work on a clinical addiction license in their home states are responsible for learning their own state's requirements and should not expect Washburn advisors to be familiar with their state's requirements. Our MA program follows the Kansas BSRB educational regulations. Students attempting to meet educational regulations of other states should check with their state to ensure that Washburn University offers the courses they need to be eligible for licensure in their home states. In addition, they are advised that it may take them longer to complete the program in order to obtain the courses they need that are different that the Kansas BSRB educational regulations.

   Please note that admission to Washburn University does not mean that you have been accepted into the Master's program.
- 2. Complete all required pages of the enclosed Application for Admission to the Master of Arts in Human Services Program with an Emphasis in Addiction Counseling.
- 3. Distribute the three reference forms to individuals whom you believe can attest to your ability to successfully complete a graduate program in human services (former professors and internship supervisors are preferred). Choose three (3) persons who have recent, extensive knowledge of your qualifications for graduate study in the human services field. These references should be able to provide detailed information on your academic abilities, commitment to human service values and ethics, emotional stability and maturity, and readiness to enter a graduate program in preparation for a career in clinical addiction counseling within the human service field. Examples of references might include a professor, an employer, and a supervisor. References should not come from family or friends; the greatest weight will be given to references from current and former supervisors, practicum/internship field instructors, faculty, or experienced licensed clinical addiction counselors or other professionals holding a clinical license, and other human service professionals as opposed to co-workers, clergy, and the like. Please also refer to earlier instructions regarding reference letters as well as reference letter requirements for those seeking transfer credits.
  - Before sending forms to the people who will provide your references, read and complete the first page of each reference form. Either waive or claim your right to inspect the reference's commentary (before you give the form to the reference) by checking the appropriate box on the first page of each reference form and sign and date it.
  - Give each of your three references the first and second page pages of
    the reference form and a self-addressed stamped envelope. Make sure
    each person knows to fully complete items 1 through 5 on the second
    page of the reference sheet and to enclose both pages of the completed
    reference (the page you complete plus the page the reference
    completes) in the envelope, seal it, sign it across the sealed flap on the
    back of the envelope, and then return the envelope to YOU. Do not
    break the seal; we will not consider reference letters that have been
    opened.
  - When ALL THREE reference letters are returned to you, place them, unopened, in your packet along with all your other completed application documents.

- 4. Attach a typed essay which briefly (3-4 pages) discusses your interests related to human services, related education and experience, and why you want to pursue a Master's degree with an emphasis in addiction counseling.
  - 5. Complete, sign and submit the Student Background History Attestation.
- 6. Attach <u>copies</u> of transcripts of all undergraduate course work to this application. <u>Original</u> transcripts must be sent from the institutions in which the course work was completed to the Human Services Department. If all of your course work is from Washburn, submission of transcripts is not required to the Department or University.
- 7. Attach a \$35.00 check for the non-refundable application fee to the packet submitted to the Human Services Department. Washburn alumni are not required to pay the application fee. Make check payable to Washburn University, with a notation that it is for MA in Human Services application fee.

#### PLEASE NOTE:

- 1. Applicants will not be considered for admission to the Master of Arts in Human Services Program until all required application materials are received.
- 2. To be considered for fall semester admission, all application materials must be received by **March 1**<sup>st</sup>. This includes all materials listed above.
