Burlew, ba '80, Lee's Summit, Mo., is the training and national academy coordinator for the FBI in Kansas City, Mo. He has been with the FBI for more than 20 years, earning several honors along the way. In 1996, he was recognized by the Department of Justice, U.S. Attorney's Office and District of Nebraska in Omaha for his liaison work with law enforcement agencies in Nebraska. In 1999, he received the Meritorious Achievement Award for his investigation and the prosecution of Operation Powerball, which led to the conviction of more than 100. In 2002, he was named "Top Gun," or law enforcement officer of the year, in Nebraska. A 2005 alumni fellow, Burlew played baseball while at Washburn.

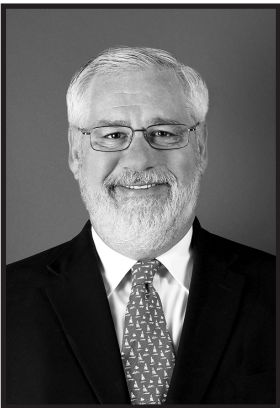
