WHEREAS: The Washburn Student Government Association passes a line-item budget each year to allocate annual Student Activity Fee dollars, and

WHEREAS: The Collegiate Readership Program has been terminated and part of the funds, totaling \$1,700 WSGA allocated to it are now unallocated, and

WHEREAS: It is to the benefit of all Washburn University students that WSGA is transparent in how it allocates its funds, and

WHEREAS: The unallocated funds should be reallocated to a service that can further WSGA's motto of "Student Serving Students", and

WHEREAS: WSGA is committed to diversity and inclusion.

THEREFORE, BE IT ENACTED BY THE SENATE:

SECTION ONE: The Washburn Student Government Association shall allocate an amount not to exceed \$1,700 to Diversity initiatives.

SECTION TWO: Initiatives will include, but not limited to, Multicultural Day, Multicultural Resource Center, WU-mester, etc.

SECTION THREE: This bill shall come into effect immediately after passage.

TITLE: Can Emporia Student Organization Donation Incentive

WHEREAS: WSGA encourages any and all student organizations to participate in the Can Emporia food drive, and

WHEREAS: WSGA would like to further incentivize student organizations' participation in Can Emporia, and

WHEREAS: The Campus and Community Affairs committee has a vested interest in the Can Emporia food drive.

THEREFORE BE IT ENACTED:

SECTION ONE: The Washburn Student Government Association shall dedicate unused funds from the Student Organization Account to be used as a monetary reward for the Can Emporia competition. The monetary rewards will be based on a tiered system.

SECTION TWO: The tiered system will be executed as follows: if the organization raises 100 cans, they are eligible to receive an additional \$100 toward their student organization funding; if the organization raises 250 cans, they are eligible to receive an additional \$250 toward their student organization funding; if the organization raises 500 cans, they are eligible to receive an additional \$500 toward their student organization funding.

SECTION THREE: Student organizations shall be eligible to receive only the amounts listed in Section Three based on their final donation count.

SECTION FOUR: No student organization shall be eligible to receive any amount of funds over the \$500 tier of the competition.

SECTION FIVE: Should the Student Organization Account become low in funds or overdrawn due to this incentive plan, funds will be utilized from the Reserve Account.

SECTION SIX: This incentive shall be used in the marketing campaign for Can Emporia.
