SPONSOR: Smith/Campa Administration STATUS: Diversity and Inclusion Committee

WHEREAS: The holiday known as Columbus Day commemorates the Italian Explorer

Christopher Columbus and his voyage to the "New World", and

WHEREAS: Columbus Day has been a federal holiday since 1937, and

WHEREAS: Washburn Student Government Association (WSGA) recognizes that the Indigenous Peoples of the lands that would later become known as the Americas have occupied these lands since time immemorial, and

WHEREAS: WSGA recognizes and values the many contributions made to our communities through indigenous peoples' knowledge, labor, technology, science, philosophy, arts, and the deep cultural contribution, and

WHEREAS: WSGA promotes the closing of the equity gap for Indigenous Peoples through polices and practices that ensure greater access to higher education and opportunities, and honor our nation's indigenous roots, history, and contribution, and

WHEREAS: Indigenous Peoples' Day was first proposed in 1977 by a delegation of Native Nations to the United Nations sponsored International Conference on Discrimination Against Indigenous Populations in the Americas, and

WHEREAS: Kansas was home to eight Native American Tribes – The Arapaho, Comanche, Kansa, Kiowa, Missouri, Osage, Otoe, and Pawnee, and

WHEREAS: Kansas became home to many more Native American Tribes – the Cheyenne, Chippewa, Delaware, Illini, Iowa, Iroquois, Kaskaskia, Kickapoo, Munsee, Ottawa, Peoria, Piankashaw, Potawatomi, Quapaw, Sac and Fox, Shawnee, Seneca, Stockbridge, Wea, Wichita, and Wyandot due to the American policy of Indian Removal, and

WHEREAS: Kansas is now home to four Native American Reservations – The Iowa Tribe of Kansas and Nebraska, Kickapoo Tribe of Indians in Kansas, Prairie Band Potawatomi Nation, and Sac and Fox Nation.

THEREFORE, BE IT RESOLVED:

SECTION ONE: WSGA acknowledges and celebrates the second Monday in October as Indigenous Peoples' Day.

SECTION TWO: WSGA supports the proposition that Indigenous Peoples' Day shall be an opportunity to celebrate the thriving cultures and values of the Indigenous Peoples. SECTION THREE: WSGA encourages Washburn University's faculty senate to pass a similar resolution.

WHEREAS: LGBT History Month provides role models, builds community, represents a civil rights statement about the contribution of the LGBTQ+ community, and encourages honesty and openness about being lesbian, gay, bisexual, transgender, and/or queer, and

WHEREAS: LGBT History is celebrated in Hungary, the United States, the United Kingdom, Canada, Australia, Brazil, Greenland, and the city of Berlin, and

WHEREAS: WSGA aims to support the LGBTQ+ community to feel safe, supported, and represented within our communities.

THEREFORE, BE IT RESOLVED:

SECTION ONE: WSGA proclaims October as LGBTQ+ History Month.

SECTION TWO: WSGA recognizes October 11<sup>th</sup> as National Coming Out Day.

WHEREAS: There are over 1000 unique signatures on a petition imploring Washburn to add mental health days to the 2021 Spring Semester, and

WHEREAS: Washburn prides itself on being a university that cares for its students and their mental health, and

WHEREAS: The WSGA is the only legislative deliberative institution for students, therefore it is our duty to represent student voices and concerns regarding the issue of university resources for student success.

## THEREFORE BE IT RESOLVED:

SECTION ONE: WSGA recommends the Academic Calendar Committee reconvene and implement "Mental Health Days" which will take the form of one day breaks in the months of February, March, and April.

SECTION TWO: The Academic Calendar Committee may decide which days the break may be on each month, but WSGA recommends that the breaks be on a Monday or Friday.
