TITLE: Men Bleed Too ORIGINATOR: Sierra Jeter and Tevin Asamoah, Mary Smith and the Queers and Allies Club SPONSOR: Smith/Campa Administration STATUS: Diversity and Inclusion Committee -PENDING

WHEREAS: Wisconsin Madison University has been providing tampons (and menstrual products) for students in both male and female restrooms since 2017, and

WHEREAS: Arkansas, Syracuse and Cornell University passed similar legislations in 2016, and

WHEREAS: Washburn University recognizes students' identities and choice of which restrooms they decide to use without persecution, and

WHEREAS: Washburn organizations have, and are working, to provide menstrual products in female restrooms, and

WHEREAS: Washburn's own Morgan Hall is already providing these resources in female restrooms, and

WHEREAS: The Washburn Student Government Association recognizes the need to accommodate those who must have access to these products (including but not limited to menstrual pads and tampons), and

WHEREAS: The WSGA recognizes transgender males, gender non-conforming, non-binary as well as those with other identities as having the right to use male restrooms, and

WHEREAS: There are students who are gender non-conforming, non-binary and transgender men that are part of our Washburn community, and

WHEREAS: We must make it a priority to establish equality and bring awareness to this problem perpetuated by Washburn University, and

WHEREAS: Recognizing Morgan hall has taken partial steps to provide these necessary products to some students who require them, however not granting access to all students that need them.

THEREFORE BE IT RESOLVED:

SECTION ONE: The Washburn Student Government stands with the members of the LGBTQ community

SECTION TWO: The Washburn Student Government Association recommends that when menstrual and hygiene products are provided in the female restrooms of Morgan Hall they are also furnished in male restrooms.

SECTION THREE: Upon passage, a copy of this resolution will be sent to Dr. Farley, Dr. Mazachek, and the facility group that is currently providing the menstrual products in Morgan Hall.
