TITLE: GENDER INCLUSIVE HOUSING ORIGINATOR: VICE PRESIDENT CAMPA & DIVERSITY DIRECTOR MORENO SPONSOR: SMITH/CAMPA ADMINISTRATION STATUS: DIVERSITY & INCLUSION COMMITTEE - PENDING

WHEREAS: Washburn University requires all first year or freshman students to live on-campus and therefore our students deserve an affordable, accommodating, and inclusive housing experience, and

WHEREAS: Washburn University has lots of students that identify as transgender or outside the gender binary and many transgender or non-binary students feel unsafe when having to live with someone whom they do not share a mutual gender identity with, and

WHEREAS: This feeling arises out of fear that whomever they are assigned to live with will not accept their gender identity and would harass them physically or verbally, and

WHEREAS: Seventy-four percent of transgender youth reported being sexually harassed at school and ninety percent of transgender youth reported feeling unsafe at school because of their gender expression, and

WHEREAS: Implementation of a gender-inclusive housing program would necessitate changes in the housing policy, contracts, roommate matching process, and residential assisting training process in order to support the program, and

WHEREAS: The aim of gender-inclusive housing would be to provide a safe living option for underrepresented minority gender, non-conforming, gender queer, and transgender students and to allow students the option to live in the comforts of on-campus housing while exploring the cultural constructions of gender identity.

THEREFORE, BE IT RESOLVED:

SECTION ONE: The Washburn Student Government Association supports inclusivity towards all our students, regardless of their gender identification.

SECTION TWO: WSGA believes the university should support inclusivity at its fullest extent and recommends Washburn University take action towards creating a Gender Inclusive Housing option for all Washburn students.

SECTION THREE: A copy of this resolution shall be sent to President Dr. Jerry Farley, Vice President of Student Affairs Dr. JuliAnn Mazachek, Vice President of Student Life Dr. Eric Grospitch, Director of Diversity and Inclusion Danielle Dempsey-Swopes, and the Residential Living Office.
