WHEREAS: The current Constitution and By-Laws state in Article II, Section 5 Subsection B, "An individual shall be removed by a 3/4 vote of the total membership of the WSGA Senate after a thorough Internal Affairs Committee hearing has been conducted, unless the WSGA member has been found guilty of violating the Washburn Student Code of Conduct, which would result in the immediate removal of the individual from the body," and

WHEREAS: If yielded time by a sitting senator said person may speak as a member of the gallery for as long as they can on the condition the sitting senator does not reclaim their time, and

WHEREAS: There are no rules concerning expelled members from attending a WSGA meeting from the gallery.

THEREFORE, BE IT ENACTED:

SECTION ONE: WSGA adds a subsection 1 to Article II, Section 5 subsection B of the Constitution and By-Laws to state, "All students guilty of violating the Washburn Student Code of Conduct policy shall henceforth be forbidden from being yielded time by a sitting senator as a member of the gallery through the duration of their probation."

WHEREAS: The Washburn Student Government Association strives to create both an academic and social environment on our campus where all students can succeed, and

WHEREAS: The Washburn Student Government Association has a due diligence to review the Student Activity Fee Allocations, and

WHEREAS: The Student Activity Fee Allocations has not been reviewed in over ten years, and

WHEREAS: It is the responsibility of the Washburn Student Government Association to determine how much each of the organizations will receive from the Student Activity Fee Funds every academic school year, and

WHEREAS: The Washburn Student Government Association has found other endeavors to put money towards to help students have a normal and fun college experience.

THEREFORE BE IT ENACTED:

SECTION ONE: The Washburn Student Government Association shall reduce the amount of money given to the Student Media from 27% down from 24% of the Student Activity fee of the 2021-2022 Academic Year, with the stipulation that each administration will review the allocation amounts each year after, determining if there is need for more cuts.

SECTION TWO: The Washburn Student Government Association shall reduce the amount of money given to the CAB (Campus Activities Board) from 15% to 14% of the Student Activity fee of the 2021-2022 Academic Year with the stipulation that each administration will review the allocation amounts each year after, determining if there is need for more cuts.

WHEREAS: The "Campaign Rules" section does not clearly say anything about a President and Vice President Campaign pair promising Cabinet positions to their friends in exchange for votes or any other benefit to the campaign, but this is clearly unethical behavior for Washburn Student Government Association.

THEREFORE, BE IT ENACTED:

SECTION ONE: The WSGA Senate adds a new subsection in Section 2 Campaign Rules to read that "President and Vice President Campaign pairs are not allowed to promise Cabinet positions or any other executive favor in exchange for votes or any other benefits to the campaign. Such promises will result in a campaign violation, at the discretion of the Student Election Board."

Subsection 2.B "Campaign posters for candidates conform to Washburn University's Bulletin Board and Poster Policy and to the Residence Halls' posting policy. A copy of these will be distributed to candidates by Student Election Board."

The WSGA Senate changes subsection 2.D of the Campaign Rules to read that "Before distribution, the Student Election Board must approve all campaign material, item by item, including posters, business/walking cards, brochures, buttons, web sites, and balloons. Before any campaign material may be distributed, each piece must be approved, received, and filed by the Student Election Board. All posters must be stamped with the official WSGA election stamp before distribution. An original may be stamped and photocopied."

THEREFORE, BE IT ENACTED:

SECTION ONE: The WSGA Senate changes subsection 2.B of the Campaign Rules to read that "Campaign posters for candidates conform to Washburn University's Bulletin Board and Poster Policy and to the Residence Halls' posting policy. A copy of these will be distributed to candidates by Student Election Board. Unsolicited emails sent by a President and Vice President Campaign pair to any portion of the Student Body population are forbidden. Such emails will result in a campaign violation, at the discretion of the Student Election Board."

SECTION TWO: The WSGA Senate changes subsection 2.D of the Campaign Rules to read that "Subsection 2.D "Before distribution, the Student Election Board must approve all campaign material, item by item, including posters, business/walking cards, brochures, buttons, web sites, emails, and balloons. Before any campaign material may be distributed, each piece must be approved, received, and filed by the Student Election Board. All posters must be stamped with the official WSGA election stamp before distribution. An original may be stamped and photocopied."
