TITLE: WSGA Funding of Organizations Policy

ORGINATOR: Budget Director Rorstrom and Legislative Director Young

WHEREAS: The Washburn Student Government Association strives to create both an academic and social environment on our campus where all students can succeed, and

WHEREAS: The Funding of Organizations Policy shall define the rules and regulations of all organization funding, and

WHEREAS: Section 4.2.2 of the Funding of Organizations Policy states that student organizations must have completed community service to receive funding, and

WHEREAS: To increase accessibility and reduce complexity of the funding process, WSGA should strike the community service portion of the Funding of Organizations Policy, and

WHEREAS: Based on the previous Funding of Organizations Policy, it is recommended that the Senate approve the updated Funding of Organizations Policy.

THEREFORE BE IT ENACTED:

SECTION ONE: The Washburn Student Government Association shall strike Section 4.2.2 of the Funding of Organizations Policy, which reads, "The Student Organization must have completed community service. To count towards this requirement, the organization requesting money must have completed community service activities as a whole organization independent from academic requirements. Failure to complete said community service shall result in a 20% reduction of total allocated monies."

SECTION TWO: The Washburn Student Government Association shall approve the 2021-2022 Fiscal Year Funding of Organizations Policy.

SECTION THREE: This legislation shall become effective upon passage.
