TITLE: Standing Up to Mental Health Stigma ORIGINATOR: Vice-Chairperson Nelson SPONSOR: Trautman/Hanes Administration STATUS: Communications Committee – Pending

WHEREAS: Many college students face mental health issues, including, but not limited to, depression, anxiety disorders, personality disorders, and suicidal ideation, especially because of the onset of these issues during young adulthood, and

WHEREAS: These issues can be compounded by a stigma in society surrounding mental health problems, mental health treatment, and discussions about mental health, and

WHEREAS: According to a recent study by UCLA (Gaddis, Ramirez, & Hernandez, 2017) researching nearly 63,000 students from 75 higher education institutions, college campuses that had higher levels of mental health stigma saw less frequent treatment-seeking behaviors among their students, and

WHEREAS: Treatment-seeking behaviors included taking prescribed medications and visiting therapy/counseling appointments, and

WHEREAS: According to the same study, students attending high-stigma college campuses were less likely to self-disclose having had suicidal thoughts or self-harm behaviors, and

WHEREAS: According to the same study, students attending high-stigma college campuses were less likely to admit to suicidal thoughts or self-harm behaviors, and

WHEREAS: According to the Mayo Clinic, mental health stigma can take many forms, including, but not limited to, negative remarks and bullying towards someone with a mental health condition, health insurance that does not adequately cover mental health treatment, negative attitudes towards mental health treatments such as therapy and/or medication, a lack of understanding from family, friends, and coworkers, and self-stigma, in which mental health stigma is internalized.

THEREFORE, BE IT RESOLVED:

SECTION ONE: The Washburn Student Government Association encourages Washburn University to conduct a study on levels of mental health stigma on the campus of Washburn University.

SECTION TWO: The Washburn Student Government Association encourages Washburn University, after conducting a study on levels of mental health stigma, to create specific recommendations for enhancing student mental health.

SECTION THREE: The Washburn Student Government Association encourages students facing mental health issues to seek treatment if they are able to do so.

SECTION FOUR: The Washburn Student Government Association encourages students to create a stigma-free environment at Washburn University by supporting one another, encouraging discussions about mental health, and being respectful and understanding towards those with mental health issues.

SECTION FIVE: In relation to mental health awareness, the Washburn Student Government Association is hosting Pause for a Cause the week of March 21-25, 2022, to support Washburn students' mental wellbeing. Pause for a Cause will also encourage students to access resources on-campus for their mental wellbeing and safety, including Washburn Counseling Services, which is free to students and which can be contacted at (785) 670-3100 and <u>counseling@washburn.edu</u>, and Washburn University Police, which can be contacted at (785) 670-1153. Off-campus mental health resources include the National Suicide Prevention Lifeline, which can be contacted at (800) 273-8255 and has a chat option at suicidepreventionlifeline.org.

SECTION SIX: A copy of this resolution shall be presented to Dr. Jerry Farley, President of Washburn University, and to Dr. Eric Grospitch, Vice President of Student Life at Washburn University.

WHEREAS: The Funding of Organization Policy states "Section 4.1 No group will be funded more than \$3,000 per year. That Allocations Committee reserves the right to cut or add money to any organization's request as long as it does not surpass the maximum;" and

WHEREAS: It also states, "Section 4.3 No more than \$8,000 shall be allocated for any specific event, regardless of how many students groups request funding for that particular event;" and

WHEREAS: It also states, "Section 6.2 Off-campus events may only be funded by WSGA up to \$2,000.00 and no more than \$500.00 for each student participating in the activity or project;" and

WHEREAS: It also states "Section 8.2 No more than \$2,000 shall be allocated for any specific event, including International Study Abroad trips, regardless of how many students are attending the event. Section 8.2.1 No more than \$500 shall be allocated to a single student for any single event, and

WHEREAS: The funds in these accounts have not been rendered near zero nor used in their entirety in recent history, and

WHEREAS: Excessive restrictions offer penalty to those (organizations) wanting to utilize these funds while offering no real protection to them, and

WHEREAS: We must account for inflation and price increases.

THEREFORE, BE IT ENACTED:

SECTION ONE: Section 4.1 of The Funding of Organization Policy shall be amended to "No group will be funded more than \$3,000 per year. That Allocations Committee reserves the right to cut or add money to any organization's request as long as it does not surpass the maximum."

SECTION TWO: Section 6.2 shall be amended "Off-campus events may only be funded by WSGA up to \$3,000.00 and no more than \$1000.00 for each student participating in the activity or project."

SECTION THREE: Section 8.2 shall be amended to "No more than \$3,000 shall be allocated for any specific event, including International Study Abroad trips, regardless of how many students are attending the event."

SECTION FOUR: Section 8.2.1 shall be amended to "No more than \$1000 shall be allocated to a single student for any single event."

SECTION FIVE: This legislation shall become effective upon passage.

WHEREAS: Then in August 1910 an International Women's Conference would be organized by Clara Zetkin, a German suffragist and leader in the women's office, and

WHEREAS: Zetkin proposed a special women's day to be organized annually and international women's day was honored the following year in Austria, Denmark, Germany, and Switzerland, with more than one million attending the rallies, and

WHEREAS: Since then, International Women's Day has become a global day that celebrates the historical, cultural, and political achievements of women, and

WHEREAS: The day also observes the support for acting against gender inequality around the world and to appreciate the efforts made by women, and

WHERES: The Washburn Student Government Association defines women to include trans women and women-identifying persons, along with cis-gender women.

THEREFORE, BE IT RESOLVED:

SECTION ONE: The Washburn Student Government Association recognizes March 8th, 2022, as International Women's Day.

SECTION TWO: This legislation shall become effective upon passage.
