TITLE: Group Funding Requests Amendment ORIGINATOR: Parliamentarian Surritt SPONSOR: Allocations STATUS: Allocations Committee – Favorable Status

WHEREAS: Currently, the WSGA Funding of Organizations Policy does not address the matter of large overlaps in membership between two or more student organizations that request funding for an event, and

WHEREAS: It would be unfair to allow two or more organizations with a large overlap in membership to be allocated more funding for a single event than if a single organization did so.

THEREFORE, BE IT ENACTED:

SECTION ONE: A new subsection 4.3.1 shall be added to the WSGA Funding of Organizations Policy that states, "No two or more organizations that request funding for a single event or project may have an overlap in membership of 75% or greater. In a case where two or more student organizations have an overlap of 75% or greater and request funding for a single event, only one of the organizations shall be eligible to receive funding and shall be held to the standard policies of such a request."

SECTION TWO: This bill shall become effective upon passage by a 2/3rds majority vote.

WHEREAS: March 30th is "World Bipolar Day", and

WHEREAS: According to National Alliance of Mental Illness (NAMI) Bipolar disorder is defined as "a mental illness that causes dramatic shifts in a person's mood, energy, and ability to think clearly. People with bipolar experience high and low moods—known as mania and depression—which differ from the typical ups-and-downs most people experience, and

WHEREAS: According to the National Institute of Mental Illness an estimate of 2.8% of adults suffer from bipolar disorder, and

WHEREAS: bipolar is severely stigmatized and shown as something it is not. People with bipolar disorder often face a lot of discrimination, by being mistakenly perceived as unable to work, moody, dangerous, or violent, and

WHEREAS: According to the National Institute of Mental Health, people with bipolar have a 9.2% reduction in life due to suicide, and

WHEREAS: bipolar awareness is vital for students and faculty on campus with bipolar to feel supported, but also a vital means of educating the general population about bipolar disorder.

THEREFORE, BE IT RESOLVED:

SECTION ONE: The Washburn Student Government Association recognizes March 30th as World Bipolar Day.

SECTION TWO: The Washburn Student Government Association will stand with those with bipolar disorder by utilizing social media and working with the Washburn University faculty, staff, administration, and more importantly our counseling services, to raise awareness and educate our students about bipolar disorder.

WHEREAS: LGBTQAI+ youth are more than four times as likely to attempt suicide than their peers, and

WHEREAS: Transgender and nonbinary youth face elevated risk for depression, thoughts of suicide, and attempting suicide compared to youth who are cisgender and straight, including cisgender members of the LGBTQAI+, and

WHEREAS: LGBTQAI+ youth of color reported higher rates of attempting suicide than their white peers in the past year, and

WHEREAS: In particular, Black transgender and nonbinary youth report disproportionate rates of suicide risk – with 59% seriously considering suicide and more than 1 in 4 (26%) attempting suicide in the past year, and

WHEREAS: A 2021 peer-reviewed study by The Trevor Project's researchers, published in *Transgender Health*, found that transgender and nonbinary youth who reported gender identity acceptance from adults and peers had significantly lower odds of attempting suicide in the past year, and

WHEREAS: The Trevor Project's research has found that LGBTQAI+ youth who reported having at least one LGBTQAI+-affirming space had 35% reduced odds of reporting a suicide attempt in the past year – the strongest association being with LGBTQAI+ - affirming schools, and

WHEREAS: LGBTQAI+ youth who report the presence of trusted adults in their school have higher levels of self-esteem and access to supportive peers is protective against anxiety and depression, including among those who lack support from their family, and

WHEREAS: The Diversity and Inclusion Committee of Washburn Student Government Association strives to ensure that Transgender students, faculty, and staff are applauded for their perseverance and resilience, and

WHEREAS: The Diversity and Inclusion Committee of Washburn Student Government Association works to provide a safe and inclusive space for transgender peoples.

THEREFORE, IT BE RESOLVED,

SECTION ONE: The Diversity and Inclusion Committee supports Transgender students, faculty, and staff.

SECTION TWO: The Washburn Student Government Association supports Transgender students, faculty, and staff.
