WHEREAS: The Washburn Student Government Association maintains a Constitution and a set of By-Laws as its governing documents, and

WHEREAS: Those governing documents set forth the Election Rules and, within them, the qualifications for office in The Washburn Student Government Association, and

WHEREAS: All Cabinet members, except the President and Vice President, must maintain a 2.5 GPA to gain and hold office, where the President and Vice President must have a 3.0 GPA, and

WHEREAS: The President and Vice President positions, as with the other Cabinet positions, are responsible for countless events, programs, and duties outside of the regular responsibilities of being students, and

WHERAS: It would be fair to set the GPA requirements for all of Cabinet, including the President and Vice President, at the same level.

THEREFORE, BE IT ENACTED:

SECTION ONE: Chapter 5, Section 1, Subsection C shall be amended to state: "The President must maintain a minimum enrollment of six (6) credit hours, at Washburn University, each semester of their term. Vice President must maintain a minimum enrollment of six (6) credit hours, at Washburn University, each semester of their term. The President must serve for the full academic year, both Fall and Spring semesters. The elected Vice President must at least serve for the Fall Semester. Both President and Vice President must have at least a 3.0-2.5 cumulative grade point average, have at least a 2.75 2.5 grade point average in the semester prior to taking office, and must maintain a minimum 3.0 2.5 cumulative grade point average to continue to hold office."
