REGISTRATION:

You MUST **COMPLETE** THIS FORM FOR **EACH SEMESTER** in which you wish to receive VA educational benefits. Failure to do so will result in the termination of your status or it may greatly delay your benefit for the upcoming semester. You will receive a short check the first and last month of the semester unless you are continuing from the previous semester. **EXAMPLE:** If you take summer off and are starting the fall term on August 9, you will be paid for 22 days (August 9-31). If you attend the fall term and re-register with Student Services for the spring, you will also be paid for the semester break, meaning there would be no interruption in payment from the fall to spring terms.

REMINDER: If you wish to receive full-time monthly benefits for Fall 2008, enroll in 12 hours or more for the entire term. Enrollment in short-term classes results in payment only for the duration of the course.
