Overall Recommendations

No new changes for any classes or our overall curriculum are recommended based on the assessment results for PSLO 2, 3, and 4. We plan to stay the course.

Consistent with last year's recommendation, greater use of videotape in supervision occurred in the Psychotherapy Techniques course; this practice will continue.

Although just reported on this year, based on MA Advisory Board feedback, a unit related to working with transgender clients was add to the Advanced Psychopathology course. Additionally, clinic materials were revised to be more sensitive to gender diverse clients.

Additionally, since the last reporting on these SLOs, education about bariatric assessments has been added to the Advanced Psychopathology class.

Additional trainings on suicide were incorporated into the internship class and Advanced Psychopathology class, consistent with previous feedback on graduate surveys requesting more training on work with suicidal clients.

Overall Reflection

Overall, assessment supports that we are meeting PSLOs 2, 3, and 4.

During the last two years, we have had very poor compliance with graduate students completing the exit survey (less than 50% completion rate). We have been emailing them to the students and asking them to turn them in to

Next year, we will hand out the exit surveys in a face-to-face class and put one student in charge of putting them in an envelope and giving them to the administrative assistant (similar to how we used to do course evaluations). Having a higher response rate will hopefully make these surveys more useful.

Overall, we have consistently upgraded our graduate courses based on feedback from the graduate students and MA advisory board (see previous description of changes).

Faculty Collaboration

Assessment results are shared with all faculty members. Faculty members receive a copy of the Advisory Board Minutes and copies of the graduate student exit surveys. All faculty also have the opportunity to provide feedback on our PSLOs and changes needed based upon assessment results.

As previously stated, the implications of the results for PSLOs 2, 3, and 4 support staying the course with what we are currently doing in our overall curriculum.

Communication & Collaboration with Students

Our PY MA PSLOs are available on our website and in the graduate catalog.

All PSLOs, MA Rubrics, and the Graduate Student Exit Survey are in the graduate student handbook that the students receive during orientation. The Department Chair goes over the handbook with the students and answers questions at orientation.

With regard to feedback, both student and supervisor sign the MA Program Clinical Progress Form (rubric) after discussing the ratings.

Consistent with the plans we stated in last year's report, we published where our graduating students presented their capstone projects in our annual newsletter.

Communication & Collaboration with External Stakeholders

Our PY MA PSLOs are available on our website and in the graduate catalog. We also explicitly discussed each PSLO at our MA Advisory Board meeting. After introductions, our first agenda item at the MA Advisory Board meeting will be assessment results.

Communication & Collaboration with University

Psychology faculty regularly attend CTEL programming related to assessment. The PY MA Assessment Coordinator met individually with Beth O'Neill for assistance in preparing this submission. It has also been helpful having Jericho Hockett in the department for consultation on assessment issues.
