Active-Duty Definition

- Persons on active duty in the U.S. armed forces for purposes other than training and will remain on active duty through June 30, 2027
 - o Includes Army, Navy, Air Force, Marines, Space Force, and Coast Guard
- Persons enlisted in the National Guard or Reserves and called to active duty for other than training or state purposes

Veteran Definition

- Have engaged in active duty (including basic training) in the U.S. armed forces and were released under a condition other than dishonorable
- Have served full-time as a Reservist or member of the National Guard and were called up to active federal duty by
 presidential order for a purpose other than training
- Have served on active or inactive duty for training in the U.S. armed forces and were disabled from an injury incurred or aggravated in the line of duty
- Are not currently a veteran, but will meet one of these definitions by June 30, 2027

Acceptable Documentation

May include, but is not limited to:

- Orders showing active-duty status in the U.S. armed forces
- Orders showing federal order to active duty for purposes other than training for members of National Guard or Reserves
- DD214 showing release from active duty with Character of Service as anything but dishonorable
- Letter from a superior officer of a National Guard member or reservist that documents the call-up to active duty and that classifies the character of service as anything but dishonorable

Examples that do NOT qualify as Veteran status

- Have never engaged in active duty in the U.S. armed forces
- Are currently a ROTC student, cadet, or midshipman at a service academy
- Are a National Guard or Reserves enlistee activated for only state or training purposes
- Were engaged in active duty in the U.S. armed forces but released under dishonorable conditions
- Are currently serving in the U.S. armed forces and will continue to serve through June 30, 2027
