Assessment Committee Meeting

The meeting was called order by Kelly McClendon at 2:02 pm.

- 1. Update on Program Assessment Reviews (Kelly)
 - a. Number of programs that submitted materials increased. Assessment plans: 2021=49 programs; 2022=66 programs; 2023=60 programs so far
- 2. SARR Report on Information Literacy & Technology USLO assessment survey, SAILS
 - a. Please see this **LINK** for the full report.
 - b. Assessment tool
 - Assessed by SAILS Information Literacy Assessment
 - Online assessment, certain number of surveys paid up front, students are asked to take this survey and provided an incentive to do so
 - This was done in the past and did not produce a good turnout. We did not conduct a survey in 2020 due to the COVID-19 pandemic. Survey was fully administered to 300 students in 2023.
 - 300 seniors proportionately stratified by college, **19.7%** response rate
 - Washburn's surveyed population was 100% seniors, comparison universities (California State University, Dominguez Hills and Misericordia University) were 49% seniors.
 - c. Overall score of **58%** for Washburn University students. This is higher than pre-selected peer institutions.
 - Washburn scored higher than or equal to pre-selected peer groups in 40 of the outcomes and objectives.
 - Washburn did have an overall larger senior population than did comparison groupings.
 - Data is only reflective of Washburn University main campus, not Washburn Tech.
 - We do not have demographic info, this has been suggested to be included for future studies.
 - It is suggested to look at transfer student data in comparison with traditional, four-year student data
 - It is suggested to look at other survey vendors
 - At the assessment conference next week, Kelly will be asking what vendor peer universities are using to assess ILT.
 - It is suggested to complete surveys independently, this may not be possible, but the option will be looked into.
 - Incentive was \$10.00.

- Vendor cost is \$5.00 per test upfront or \$6.00 if paying after.
- ILT is assessed every three years. The Assessment Committee will discuss options for assessing ILT in 2026.
- No qualitive questions utilized on SAILS survey.
- There will be a CTEL event focusing on the ILT USLO data on Wednesday, November 15th, 2023 at 2:30 pm by Kelly McClendon and Sean Bird.

- 3. Update on Fall 2023 Assessment Grant Submissions/Process

 - b. This will be posted on the Assessment site. Winners may be asked to present their findings at Assessment Extravaganza.
- 4. Update from Assessment Extravaganza Committee
 - It was decided to have assessment tables and table topics for 8 tables.
 - We would like to have two presenters per table with the idea that they will switch off. This eliminates one person talking the whole time and allows presenters to attend event.
 - 12 minute presentation with 3-minutes between tables, music to switch tables
 - Low-stakes formative assessment CTEL tech teaching fellow has agreed to have a table, still needs a co-facilitator.
