Nancy welcomed and thanked everyone for attending the meeting today. She informed the committee that with the newly formed faculty senate, the Research Committee has undergone a couple of changes. The committee now needs a member from faculty senate on it. Patricia said she is a member so we do not need to request one. Also, the committee needs to elect a chair. After discussion of the chair's duties, nominations were taken and the committee voted and Patricia Renn-Scanlon is the chair of the committee. She asked that Nancy proceed with the meeting.

Nancy informed the committee of the balance of \$9,100.00 that we can award today. Please remember, at the April, 05 meeting, funds were awarded for this fiscal year. Nancy said that she will see if she could find some additional funds in the amount of \$6000, so that most of the applications can be funded. The committee discussed the awarding and decided as a guideline to split the awarding to half of the funds in the Fall and half in the Spring.

In addition, two questions were raised. Do we award funds to an individual who has already been awarded research monies that same year. After much discussion, it was decided that the applications will still be considered, however, the priority of the application will not be as high as an individual who has not been awarded.
