 - Lanning helped with general education documentation. The reality is if a student has completed the KBOR package anywhere – we take it all as general education. If they do not finish elsewhere, then they can be asked to take the needed courses.
 - Programs can also require courses as prerequisites that are also general education related.
 - Cook asked if credit as C or better also counts yes.
 - Ricklefs noted that it has all been a learning process. We should continue to give
 one another grace as we complete decision making on the package.

- 24-19 Significant Program Edits Religious Studies, BA
 - Approved.
- 24-20 New Program Proposal Mathematics Secondary Education: Core Mathematics 6-12
 - Details from Cook: there are new licensure requirements from the state coming down the pike to be able to teach in high schools. This is a combo of middle and lower high school math.
 - Steffen: there is a licensure committee; having this ready now will ensure we are ready to go when it passes.
 - Approved.
- 24-21 New Program Proposal Graduate Certificate in Communication and Leadership
 - Altus asked about the new graduate council responsibilities; academic programs and changes will now go from graduate council to senate rather than going through academic affairs.
 - Schnoebelen with details: it is an offshoot of the Master of Art in communication and leadership. Can be completed in one year and be in addition to an existing graduate degree or as a stand-alone.

- Steffen asked whether learners could move on to the graduate program without any issue. They can, as this is their first year of classes; they can branch off after the first year or any time. The admissions process is the same as the full MA program.
- Altus was surprised there were not hard data in the details of the item.
 Her experience is that it has been required with notes of support.
 Schnoebelen indicated that there was not as much veracity with the inclusion of those details (i.e. did not include official data in the proforma) as they were not seeking additional resources. Steffen suggested more standardized requirements if one department must do it, all must do it.
- Wagner asked how they will determine success of the certificate. Perhaps this is something to discuss for assessment purposes.
- Lolley voiced support for the certificate; something employers want to see.

- 24-22 Significant Program Edits Forensic Biology, BS
 - Changing details to ensure people do not take MA112 (Mullican). Adding 301; other courses are getting new names and numbers. Capstone language is being replaced with a research course. All changes are meant to make things more flexible for students. accreditation standards change all the time, always a moving target.
 - Auditors will adjust if other courses are taken for math (Cook)
 - Lolley noted that CJ410 was being removed as those materials are covered in other courses outside of CJ. Wagner corrected that not all CJ410 is taught in those other courses, just what is necessary for the degree.
 - Confusion about the materials based on color coding. Broxterman is working to standardize the color coding and all details in Course Leaf.

- Kelly McClendon asked for feedback on the <u>2022-2023 Program Assessment Report</u> posted on Assessment webpage
 - a) Rhonda Boeckman asked for suggestions for Indirect Measures. Committee members responded with these suggestions:
 - i) Surveys, newsletters, survey and interview area employers, hiring managers and associates in the area. This assesses new hires; Student focus groups
 - ii) Recruiting alumni to return to campus and speak to us in a focus group format, sharing what they learned and what they wish they had learned
 - b) Rhonda also asked how often Each measure must be addressed, such as (PSLOs) every 2 to 3 years.
 - i) Jennifer Ball said there is not a set rule for this, but best practice is: something should be addressed every year. Different accreditors may have different requirements for this concerning how often measures must be addressed.
- I. Assessment Software Purchases- New Watermark products are being purchase
 - a. Planning and Self Study is being purchased and will replace TaskStream. This is a Watermark product. There is not currently a date set for stopping TaskStream support so that programs can continue to use it until it's their turn to submit a report for review in the new 3-year cycle. This will go live Spring 2025.
 - b. Student Learning & Licensure is being purchases to replace the USLO score submission software. It will also be use for artifact rating for University-wide assessments. This system will be piloted in summer 2024 and will go live for all USLO score submission for the fall 2024 semester.

International Education / International WTE Committee Feb. 22, 2024, 4-5 pm, International House

In attendance: Liviu Florea, Hillary Lolley, Crystal Stevens, Ye Wang, and Baili Zhang (ex officio - Secretary); Courtney Sullivan and Tom Prasch reviewed agenda remotely and voted by email.

Reports & Announcements

Zhang announced that 29 visiting students from Fukuoka and Chiba (Japan) were on campus for 2-3.5 weeks of intensive English studies, nursing class & clinical observations, and cultural experience. Zhang reported that spring 2024 saw 67 more international learners (by head count) than spring 2023, an increase of 33%.

Approvals

November 16, 2023, meeting minutes were approved.

Discussion

Discussion was held regarding Guatemala and China (with the above corresponding programs) being on the travel advisory list. The committee agreed that, other than using one-size-fitting-all approach, key factors will be used to determine if it is safe and appropriate for travel. Such factors include site selection and security, local (partner) support, program management, proximity of US consular assistance when needed, neighboring schools' (PSU, FHSU, UCM) recent travel / sending experience and history. Documents / History showed that WU used the same policy / similar criteria as above in the past to assess travel safety when there is a long-standing travel advisory from the US state Department, e.g., Colombia, Cuba, Nicaragua, Haiti, etc. All those trips happened without incidents. Records also showed that the Haiti program was reversed / canceled once when the travel advisory changed for the worse than when the program was initially proposed and approved.

Interdisciplinary Minors & Certificates Complete Proposal

Rationale: The College of Arts and Sciences has been exploring the creation of several new interdisciplinary minors and certificate programs. These proposed new programs combine existing, regularly taught classes from different disciplines into a coherent grouping focused on a relevant and innovative theme. Along with existing minor programs, these new programs will provide students more opportunities to complete a minor or certificate that complements their major area of study; advances their personal, professional, and civic goals; and improves career readiness and marketability in a world where job descriptions will continue to change frequently.

Interest in creating these new interdisciplinary programs predates KBOR's proposal of a systemwide plan of general education, but the new system has provided even greater motivation and opportunity for such programs. The KBOR system reduces the overall number of general education credits required and students in some degree programs will have greater flexibility to take elective courses or complete an optional minor or certificate program.

<u>Proposal Process:</u> Proposing these programs has been a thoughtful and collaborative process over the past year. The work began in August 2022 when CAS department chairs began brainstorming the potential for new interdisciplinary minor and certificate programs that would make use of existing, regularly taught classes not requiring prerequisites.

In spring 2023, the CAS Deans office invited CAS faculty to participate in "faculty success groups" to look more carefully at the possibilities brainstormed by chairs.

In fall 2023, an ad hoc committee consisting of faculty from all five CAS Divisions was formed. The committee reviewed existing catalog requirements for minors and certificates. The committee next proposed revised "rules" to govern existing and new minors and certificates and to distinguish between "departmental" (one discipline) and interdisciplinary (more than one discipline) programs. These rules are as follows:

- A departmental minor in the College of Arts and Sciences shall consist of no less than 15 hours in one discipline as specified by the department. Of these, at least 6 hours must be at the upper-division level. Students must have a grade of C or better in each course in the minor. A minimum of six hours used to meet the minor requirements must be earned in residence at Washburn University.
- An interdisciplinary minor in the College of Arts and Sciences shall consist of no less than 15 hours in at least two different disciplines as specified by the minor program. Of these, at least 9 credit hours must be outside of the major discipline.

- Students must have a grade of C or better in each course in the minor. A minimum of six hours used to meet the minor requirements must be earned in residence at Washburn University.
- A certificate in the College of Arts and Sciences shall consist of at least 9 credit hours. Students must have a grade of C or better in each course for the certificate. A minimum of six hours used to meet the certificate requirements must be earned in residence at Washburn University.

The ad hoc faculty committee also continued to review the work of chairs and faculty success groups and solicited feedback from the Divisions on the proposed interdisciplinary minors and certificates. It now brings forward # (will add exact number when complete) new interdisciplinary minors and # new interdisciplinary certificates for consideration.

Oversight of New Programs: These proposed interdisciplinary minor and certificate programs will be coordinated and overseen by the College of Arts and Sciences Deans Office. Because they all rely on courses that are regularly taught as part of other, existing programs, they are at the very least revenue-neutral programs. No new investments in facilities or faculty are needed. The majority of courses come from within the College, but relevant courses from outside of the College have been included as well. Faculty who apply to serve as "program directors" may receive a small administrative stipend (up to \$500) depending on the number of students enrolled into the program. The College office will provide administrative support with scheduling and promotion of the programs. We will explore the creation of 4-year degree plans that integrate likely major/minor pairings.

<u>Conclusion:</u> Packaging existing courses into new and innovative minor and certificate programs will help to find new audiences for existing resources. Moreover, analysis conducted by the ad hoc faculty committee revealed that, in their proposed configuration, many of the interdisciplinary programs are unique to the region and state. These programs will help to enrich the learning and career opportunities of students in a wide variety of major disciplines as well as different degree programs including associate and applied associate degree programs.

Description / Rationale: We are making a number of changes. Some of these are due to ensuring degrees are within 120 hours. Others are curriculum changes to better satisfy the KSDE standards. This change is 'significant' because it inactivates the BA and BS versions, and it also adds an Education course.

We have been offering options of a BA, BS, or BEd in Math Secondary Education. The Math and Education courses were identical in all three degrees to satisfy State requirements. The additional degree requirements for the BS and BA push these options well over the 120 hours, even with the new lowered General Education program. Because of this, we have decided to inactivate the BA and BS versions and keep only the BEd.

We are making curricular changes to better align with the KSDE standards and to lower the math requirements for the degree to 40 credit hours. We are replacing the requirement of MA 204 Number Theory/Discrete with MA 260 Introduction to Number Theory. MA 204 was created to satisfy a KSDE standard for both Middle School Math Education majors and Secondary Education Math majors. We have found that this has not been a good mix as the Middle School majors tend to struggle with the concepts required for the Secondary Ed majors. Making this change will allow us to focus MA 204 on standards for middle school math. The content of MA 260, which is already required for our pure math majors, better aligns with the Secondary Ed standards.

We are eliminating MA 230 Math for Secondary Education as this course has been inactivated (the course should have been removed from the degree previously when we added MA 204 but this change was mistakenly left off).

To bring our required math hours to 40 credits (the same as our other degree tracks), we are reducing the number of times students are required to take MA 380 Problem Solving from twice to once. Students will still have the option to take MA 380 a second time as it is a course listed in our "Select two of the following" courses. We also are adding two 1 credit options to the "Select two of the following" courses list, namely MA 315 Seminar: Teaching Mathematics and ED 349 Middle Level Mathematics Practicum. Our list of options allow students to decide if they want to do a capstone project, obtain more practice with in-depth problem solving, or obtain more practice teaching before doing their student teaching semester.
