## American Rescue Plan (HEERF III) Student Fund Quarterly Report

Washburn University and Washburn Tech previously signed and returned to the Department of Education the Funding Certification and Agreement Emergency Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act. By drawing down the funds from the American Rescue Plan (ARP), Washburn University and Washburn Tech agreed to terms and conditions under the ARP. Washburn University and Washburn Tech received a total \$7,207,148 to provide Emergency Financial Aid Grants to students. In total through the student portion of HEERF I, II, & III, Washburn University has received \$11,707,322. In February 2022, the final portions of HEERF funding were provided to students. No funding remains at this time.

\$253,383.29 of the Higher Education Emergency Relief Funds were utilized in this quarter to make 653 grants to 650 students. This was done to account for students that had extenuating circumstances for expenses as a direct result of COVID-19, lost a scholarship as a result of an extension of their academic timeline as a result of COVID-19, or received a block grant. \$1,300 in uncashed checks were removed from Washburn Tech's total and included in the remaining balance to disburse.

In this quarter, 651 grants have been made to 650 students. The average received per student in this quarter was \$389.82. In total, with all HEERF funds in all quarters, 12,640 grants have been provided to 6,317 students. The total provided is \$10,983,945.40 and the average grant per student is \$1,738.79.

With CARES, CRRSAA, and ARP 1,345 grants have been provided to 1,129 students. The total is \$723,376.60 and the average grant is \$640.73.

At this time, all student emergency HEERF grants have been depleted.

In this quarter, students that lost academic resources due to an extension of their academic timeframe as a result of COVID-19 or had expenses as a direct result of COVID-19 were eligible to apply for funding. If approved, student were eligible to receive the value of the lost resource or expense as a result of COVID-19. On February 15<sup>th</sup>, remaining funds were provided through a \$300 block grant. Criteria for the block grant included undergraduate students enrolled in 12 or more hours in the Spring 2022 semester that owed a balance. Priority for the block grant was given to students with the lowest EFC until funds were depleted. The block grant was provided directly to students and was not applied to outstanding balances.
