Washburn University and Washburn Tech previously signed and returned to the Department of Education the <u>Funding Certification and Agreement</u> Emergency Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act. By drawing down the funds from the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) and American Rescue Plan (ARP), Washburn University and Washburn Tech agreed to the terms and conditions. During this quarter, Washburn was notified of the HEERF III (ARP) allocation. This increased the total amount to provide Emergency Financial Aid Grants to students from \$4,500,174 to \$11,707,322. Washburn and Washburn Tech intend to fully utilize the amounts provided. Plans for utilizing these additional funds are in progress.

Before processing CRRSAA funds in a block grant, Washburn wanted to ensure that CARES Act funding was fully utilized and the CRRSAA drawdown requirement was met. In order to accomplish this, a block grant of \$500 was provided to 275 in April 2021. Criteria used to determine recipients is shown below under Spring 2021 CARES Block Grant.

The remainder of CRRSAA funds were utilized in a block grant processed in May 2021. 5,109 Washburn University and 1,030 Washburn Tech students may have been eligible to receive CRRSAA funding. 3,989 Washburn University and 348 Washburn Tech students met the institutional criteria to receive funding. Criteria to determine student grants is shown below under Spring 2021 CRRSAA Block Grant.

In June 2021, a block grant of \$500 was provided to undergraduate students with a 0 EFC that were enrolled in 9 hours or more in the Summer 2021 semester.

4,297 grants have been made to 4,038 different Washburn University students in this quarter. The average grant per recipient is \$568.18. To date with the CARES and CRRSAA grants, 7,376 grants have been made to 4,688 Washburn University students. The total grant is \$4,132,859.50 with an average grant of \$885.46 per student.

340 grants have been made to 339 Washburn Tech students. The average grant is \$320.94. To date with the CARES and CRRSAA grants, 820 grants have been made to 578 students. The total grant is \$367,526.60 with an average grant of \$1,102.99 per student.

Spring 2021 CARES Block Grant

\$500 block grants were provided to 276 students to close out funding for HEERF I. Students were prioritized based on financial need based on an EFC under 20,000 and a balance of \$500 or more owed to Washburn University. Students were awarded based on EFC starting from 0 and working up. Eligibility was reviewed based on information as of 04/13/21.

<u>Eligibility</u>

- Enrolled in 12 or more hours
- Degree Seeking
- Balance of \$500 or more
- Maintaining Satisfactory Academic Progress
- Not enrolled in an online only program
- Excludes students that received CARES from the Spring 2021 application

Students receiving the grant were sent the following notification.

This afternoon, you were selected to receive a special disbursement of the CARES Act. A check for \$500 should be available for you to pick up at the Cashier window in Morgan 103 by 10AM tomorrow. Because this is a special disbursement of the CARES Act, it will not be sent out via direct deposit. If you wish to apply this to your balance at Washburn, the cashier will be able to assist you. If you do not pick up this check, it will be put in the mail within 2 weeks.

Spring 2021 CRRSAA Block Grant

Spring 2021 CRRSAA criteria was determined with an effective date of 05/21/21. Eligible students must be degree seeking enrolled at least half-time as of the effective date for the Spring 2021 semester. The table below determines which category the fell in to based on enrollment. High school students dual-enrolled were not eligible.

Eligible students with exceptional financial need were guaranteed to receive funding. Students with exceptional financial need were determined to be full-time Pell grant student and full-time 0-10,000 EFC non-Pell students. Students with exceptional financial need received an additional amount of the grant. The table below shows the amount the student could receive.

This past spring, Washburn received approximately \$2.25 million in additional funding through the Coronavirus Response and Relief Supplemental Appropriations Act(CRRSA). After reviewing the regulations and guidelines, grants were awarded last week through this funding. All post-secondary, degree seeking students who were enrolled in 6 or more hours at the end of the spring 2021 semester received some additional funding. CRRSA grants range from \$125-\$1000 and were distributed Thursday, May27th.

In addition to the above funding, Washburn will be receiving approximately \$7 million in appropriations through the American Rescue Plan (ARP). We are currently reviewing the regulations and guidelines to the ARP grant and will most likely distribute sometime early fall. We look forward to seeing you on campus this fall, back in the classroom face-to-face and enjoying the full slate of activities that Washburn is scheduling for you. As we prepare for the fall we continue to support you in your pursuit of your educational goals and encourage you to get enrolled if you have not already.
