SB 19-20 #154

TITLE: WSGA By-Law Amendment
ORIGINATOR: Internal Affairs Committee
SPONSOR: Internal Affairs Committee
STATUS: Pending

WHEREAS: The Constitution and By-Laws are the governing documents of the Washburn Student Government Association, and

WHEREAS: It is important that WSGA keep these documents up to date and reflective of best practices, and

WHEREAS: It has become apparent that the WSGA By-Laws do not accurately reflect the responsibilities of committees and the cabinet.

THEREFORE, BE IT ENACTED:

SECTION ONE: A new subsection 5.B.1 will be created under the Committees section and shall read as follows:

1. These activities include, but are not limited to:
 - a. Success Week: The week before finals week each semester where WSGA hosts a variety of events with the goal of supporting students before finals.
 - b. Pause for a Cause Week: A week dedicated to hosting events and informing the student body about the importance of mental health and self-care.

SECTION TWO: A new subsection 6.D will be created under the Committees section and shall read as follows:

- D. Coordinate Spring elections of WSGA President, Vice President, and Senators alongside the Chief of Staff and the Election Board.
 1. This includes reimbursements of candidate spending up to the limit set in the election rules, creating marketing materials and giveaways to promote elections, and hosting the annual Spring Break Kickoff event.

SECTION THREE: A new subsection 1.C will be created under the Cabinet and Executive Board section and shall read as follows:

- C. Members of the WSGA Cabinet shall execute legislation and assist in coordinating events and activities of the WSGA committees.
 1. WSGA Cabinet members shall not be tasked with solely planning and executing events without working with a WSGA committee with the exception of Homecoming, which is planned and executed by the WSGA Vice President in coordination with the University Homecoming Committee.

SECTION FOUR: Subsection 2.D under the Cabinet and Executive Board shall be amended to read as follows:

- D. The WSGA Executive Board shall meet ~~on a weekly basis as determined by the WSGA President to be the day and time that at least a quorum can be present.~~ at least once at the beginning of each Fall and Spring semester.

SECTION FIVE: A new subsection 4.A.5 under the Cabinet and Executive Board section shall be entered and all subsequent subsections shall be renumbered as appropriate. This new subsection shall read as follows:

5. Chair the University Homecoming Committee and delegate homecoming tasks to other WSGA Cabinet members, Senators, and committee members.

SECTION SIX: Subsection 4.A.6 shall be amended as follows:

6. Oversee the activities of the WSGA project committees, advisory boards, ad-hoc committees, ~~and Senate liaisons between student organizations and the WSGA.~~

SECTION SEVEN: Subsection 1.C under the Elections section shall be amended to add “each semester of their term.” after “Vice President must maintain a minimum enrollment of six (6) credit hours, at Washburn University.”

SECTION EIGHT: These amendments shall become effective immediately after passage by the Senate.
