WHEREAS: The Washburn University Board of Regents (WUBOR) shall authorize Washburn University to levy a student activity fee, which shall be used to provide an academic and cultural environment in which every student may attain the highest possible level of growth and development, and

WHEREAS: Washburn Student Government Association (WSGA) shall be the primary agency responsible for recommending the dollar amount of the student activity fee and shall consider present and future enrollment trends, as well as economic conditions such as wages and inflation, and

WHEREAS: WSGA funding should offer the greatest benefit to the largest number of students possible. WSGA will not fund any activities and/or projects that discriminate on the basis of race, sex, religion, creed, age, national origin, sexual orientation, academic major, or level of undergraduate study, and

WHEREAS: The current Student Activity Fee is \$55, and

WHEREAS: The fee is \$55 per student regardless of the number of credit hours enrolled or whether online or in person, as per SB 18-19 #015 passed by the WSGA senate during the Surritt/Henry Administration¹, and

WHEREAS, the current Student Activity Fee has not been increased since WUBOR approved an increase on June 21st, 2018², nearly five years ago.

THEREFORE, BE IT ENACTED BY THE WSGA SENATE:

SECTION ONE: The Student Activity Fee charged to each student shall change at the same percentage rate as tuition in the proposed fiscal year, as approved by the Washburn University Board of Regents

SECTION TWO: A copy of this legislation shall be presented to the Washburn Board of Regents on March 23rd, 2023 to approve this change. President Hanes and Vice President Leffingwell will present this proposed fee model change.
