TITLE: Official Initialization of Special Events ORIGINATOR: Coulter/Durst Administration SPONSOR: Coulter/Durst Administration STATUS: Committee of the Whole - Passed

WHEREAS: The Washburn University Student Government Association (WSGA) shall be tasked with enriching campus and student life, and

WHEREAS: WSGA sponsored events are a critical part of student engagement and campus enrichment, and

WHEREAS: committees are the basis of all legislation and action from WSGA, and

WHEREAS: previous legislation regarding this committee failed to include the addition into the by-laws.

THEREFORE, BE IT ENACTED BY THE WSGA SENATE:

SECTION ONE: Article IV, Section 3 of the WSGA by-laws shall be amended to include a subsection 3.4.

SECTION TWO: This Article IV, Section 3.4 of the WSGA by-laws shall be amended to read:

SUBSECTION 3.4. SPECIAL EVENTS COMMITTEE

The Special Events Committee shall be responsible for organizing sponsored special events to aid in enriching student life. This responsibility will also extend to any necessary and relevant legislation pertaining to the creation of these events for this purpose.

SECTION THREE: This legislation shall become effective upon passage and bearing the signature of the WSGA President and Vice President.

TITLE: Official Initialization of Special Events ORIGINATOR: Coulter/Durst Administration SPONSOR: Coulter/Durst Administration STATUS: Committee of the Whole - Passed

WHEREAS: The Washburn University Student Government Association (WSGA) shall have legislation that matches the intent and practice of committees, and

WHEREAS: previous legislation regarding committees does not reflect current practice and intent.

THEREFORE, BE IT ENACTED BY THE WSGA SENATE:

SECTION ONE: Article II, Subsection 1.1 of the WSGA by-laws shall be amended to read:

SUBSECTION 1.1: THE STUDENT ACTIVITY FEE REVIEW COMMITTEE

This committee is tasked with evaluating and proposing any changes to the Student Activity Fee such as the fee itself or the amounts through which the fee is distributed "off-the-top." The committee shall be chaired by the WSGA Budget Director and be composed of at least one representative from each organization that receives money off-the-top from the Student Activity Fee, including Student Media/Publications, Campus Activities Board (CAB), and Spirit Squad. The Director of the Office of Student Involvement and Development, the Vice President of Student Life, and the Vice President of Administration and Treasurer may all act as ex-officio, non-voting, members of the Student Activity Fee Review Committee. Any findings of this committee regarding the fee amount charged to students must be presented to and approved by the WSGA Senate before a recommendation is made to the Washburn University Board of Regents.

SECTION TWO: This legislation shall become effective upon passage and bearing the signature of the WSGA President and Vice President.
