VII. Public Forum I:

- a. Kara Kendall-Morwick, Director CTEL & English Professor
 - i. Thank you! I appreciate the opportunity to come and speak with you! I am the director of CTEL. This is not something that students hear about a lot, but what we do is we provide professional development for professors so that they can teach you better! The handout that I have is a list of all of the events that we host and things that we do to help professors to be better professors. There are lots of workshops and other things, teaching circles, panel discussions, coffee talks, there is a director of online course education that works with us pretty closely to make sure that we can make our online courses as good as possible. We also take the time to celebrate the teaching and accomplishments of our professors and faculty!
 - ii. There are 4 pillars in CTEL:
 - 1. Active and Engaged Learning
 - 2. Assessment
 - 3. Online and Hybrid Education
 - 4. Inclusive Pedagogy
 - iii. There are a lot of different staff members that keep this program going. They help with a lot of things related to D2L and so many other things to make sure that professors are working with students in a way that is beneficial to all. There are also certain professors that work with CTEL to make sure that this is reaching every department. Each of these folks also

oversees specific parts of the program to make sure that there is a diversity of opinions and information. There are also teaching fellows. There folks make sure that they are engaging with students and the CTEL program in certain ways. There are some departments that have a lot of representation in CTEL, and there are some departments that have their own system for professional development. We have about a 75% rate of faculty that is engaged in CTEL events; this is a great number and it really shows how WU professors are really engaged in ensuring learning for their students.

- iv. There is a CTEL Certificate Program! This is all voluntary, but we do want to make sure that we are recognizing those that are doing a lot for the program. We do have some things that we do to recognize these folks and there is an option for professors to chose which certificates they are most interested in. Some departments do require a CTEL certificate for promotion and tenure. They also do awards to departments to make sure that departments are also participating. Staff get stickers and everybody can see how many you have!
- v. Director Kerney: You talked about AI in your last meeting and how you are going to get professors to be more well-versed in it, so I was wondering if you could share that info with senate?
 - 1. We do hear a lot of questions about it. We have developed programming to address a lot of questions and concerns. Should CTEL have an official policy? We don't want to take a pro or con stance, but we should recognize that these AI things do exist and have uses, but they do have some ethical concerns. You want to be able to meet folks where they are with it. The worst thing you can do is pretend that it doesn't exist. You have to be able to articulate why this tool is not applicable to your learning in this realm.
- vi. Senator Bourell: What strategies does CTEL use with designing online courses?
 - 1. We have a pretty new person that does a lot of work on this. A big focus of hers is accessibility. All materials must be fully accessible, so she is leading the programming on that to make sure that this is happening.

She makes recommendations and criteria to make sure that online courses are quality. They are working on redesigning these. There are people in these workshops to redesign their courses and see the benefits of doing so.

- vii. Chairperson Brungardt: What can students do to support CTEL?
 - 1. I think that the most important thing is to let us know what you want faculty to know. WSGA does a lot to help this because we talk with CTEL on purpose. We want to know what is not helpful and who is doing a great job of implementing these and how it impacts you. We want to hear who is impacting you and how we can get them to participate in CTEL as well and share with us what they are doing well and how others can do it, too!
- viii. Chairperson Brungardt: Are end of the year evaluations taken into consideration by CTEL?
 - 1. These are usually not something that we have access to. There are average scores that we get for like gen ed courses, but we don't have the ability to look at all of the information. Danny Wade did a talk recently about how to get the best feedback on course evaluations; how do you get more feedback, how do you use it to be better, etc. We hear from faulty, but this is not something that CTEL really directly interacts with.
 - ix. President Coulter: I want to give you kudos. I have lots of CTEL folks as professors and I think that it is great that we have this culture on campus and we really do see how it affects students.
 - x. We have a lot of events, and we did have a lot when there were only 1-2 people there, but this was also our highest contact hour semester, ever. This is super exciting! There is a lot that makes professors overwhelmed, so we are really glad that we continue to see folks and get other kinds of interaction and involvements.
- b. Michael Gallegos, President of Washburn Student Bar Association
 - i. "We have been ballin out with that" Micheal Gallegos, referring to the growth of the 1L class and the raising of the student activity fee.

- ii. They have been hosting events and doing a lot more for students. They talked to lawyers, swing danced, met with alumni, and this gave me a lot of clarity for what we should do next semester.
- iii. The alumni are vital.
- iv. We want to bring some of you "across the pond" and bring you to the law school
- v. Maureen (aka Mo Wetta): I am the communications director and I serve on other committees. I did a lot of this kind of work in my undergrad and I want to highlight that we have done a lot of work to engage students a lot more. We send out a weekly newsletter! They have gotten a lot more views on this, and that is really exciting. We have also borrowed a homecoming spirit week! This is cool!
- vi. Cade L.: Parliamentarian and Rep at Large. I am dressed this way because I am a rebel teen. We want to line our things up with yours so that we can do a lot more together! I look for all students at the law school, and since I am the Rep at Large, I represent all students. I run the meeting efficiently.
- vii. Gallegos: I want to make sure that I continue to foster a relationship with you guys and rich alumni.
- viii. Chair Ross: How many people are in your WSBA.
 - 1. 15 members
 - ix. Senator Barbery: I work at the alumni association. I work with the 2Ls sometimes. They have done really good work with our alumni! They have a better personality than I do.
 - x. Senator Cervantes-Rodriquez: What were your spirit days?
 - 1. There are different topics every day and people win and get a different prize!
- xi. President Coulter: Thank you for coming. I want to give kudos to Maureen because their social media is going really well.

 What was your outfit for Tuesday?
- xii. Senator Bourell: How do you think your impact has affected the students at the law school?
 - 1. Since we have done more, we have seen a lot more engagement with student orgs
- xiii. Parliamentarian Sharp: How would we best get into contact with a WSBA member?

- 1. This would be sick. Talk to Kate, Kate will give you my email.
- xiv. Director Hammes: I am our marketing director. I am not familiar with the law area. What sort of student orgs do you have
 - 1. There is a variety. It depends on the practice that you want to go into. There are about 35 of them
- xv. Senator Barbery: Is this not just what you dress like?
 - 1. Usually I dress like a dad and wear golf clothes.
- xvi. Director Clark: Have you ever been told that you have a celebrity lookalike?
 - 1. Is it Ryan Gosling, by chance
- xvii. Senator Mcfan: What are the requirements to be in WSBA?
 - 1. It depends on the position. It really just requires you to be voted in. Law prom—that's how *we* have fun. It gives us a chance to wild out. There are non-representative positions, but most of them have to be elected.
- xviii. Senator Bourell: Can you explain what the LSAT score of 155 means?
 - 1. 155 is the average of this 1L class, and the national average is 152. We are looking to keep improving on these scores. This is a pretty good indicator to see how well you are going to do well in law school.
 - xix. Chairperson Ross: How closely do you work with the administration at the law school to represent the students?
 - 1. This is something that we do a lot and something I wanted to do more in my tenure in this position.
 - xx. Senator Motes: What undergrad experiences prepared you best of law school?
 - 1. I actually didn't plan to go to law school. Even for me, you can still get all the things done and get to law school. Even if you don't prepare, you can still go! Take the time to study for the LSAT and keep your grades up.
 - 2. You don't have to do a specific thing to get to law school. I did student government at WSU and this propelled me into going to law school.

- 3. All of the things that they said. You have to do something hard and find yourself dealing with adversity. It's all about the next thing.
- xxi. Senator Motes: What are your opinions to objecting to leading on a cross?
 - 1. You can ask leading questions on a cross examination.
- xxii. Senator Stevens: Would you say that it paid off for you to LEAP or would you like to have done a 4th year?
 - 1. LEAP really paid off for me because I've known that I wanted to go to law school since I was 14. This helps you pay for school and do so many other things, so I would do it again.
