- a. Halloween Safety: Director Redington
  - i. Why is this important? We want YOU to stay safe!
  - ii. Under KS (and WU) law, you have to be 21 to consume alcohol, you do need consent for sexual action and conduct, and you must have a BAC of .08 to drive.
  - iii. Check your food and drink! Know what to look for to make sure that you are not ingesting anything that you did not intend to! Don't leave your food or drink unattended.

- b. Updated Budget Proposal: President Coulter, Ryan Durst, Meredith Ginn
  - i. There are 2 different forms here, so make sure that you are looking at the new ones and the old ones side by side.
  - ii. We are updating the budget because we have our final numbers of how many students are enrolled at Washburn University. This means we now know exactly what the # of WU students paying the activity fee is. We allotted for 5,000 students and we actually have 5,427 students.
  - iii. We are currently giving 238k to other organizations. Homecoming, Student Media, CAB, and WSGA are all getting different allocated amounts. Homecoming went down, the rest of the differences were increases.
  - iv. Senator Hastings: Was Daily ops based off of last year, and why are we spending more than last year?
    - 1. We have a bigger senate than last year.

- v. Pay has increased because we didn't account for paying Lillian a full salary over the summer, but we did pay her. We also didn't plan on a Special Events chairperson, and we have to pay that person. We also opted to pay folks for Retreats because we asked them to prepare materials.
- vi. Chairperson Ross: We were a little confused because there were \$6,000 on the WU Fest line item and it is not listed on either budget.
  - 1. This was technically not passed. I just want to put that out there. Now that WU Fest is over, we know exactly what they spent on it, and that was about .5 of what we used. We decided to lower it not knowing that you were actually planning to use that money! So sorry! There is still \$ available and I am *always* happy to pull from my administrative fund!
- vii. Director Clark: I was super careful with the budget because I knew that I had a committee that doesn't have a budget, and it is weird to see that I don't have any money now and it feels like I am being penalized even though the committee could use it...
  - 1. Would it be beneficial for you to have a committee fund?
  - 2. YES! Please give us funding! We were under the assumption that we were going to have money, so we think that it would be best if we would have this as a line item for SE.
- viii. Senator Lloyd: There is a WU Fest line item, which means that you should still have 3,000 left to plan things.
  - ix. Director Ginn: I don't think that any of the discretionary fund has been used, and you can still use the WU Fest line item to fund things.
  - x. President Coulter: You still have \$500 left over! Is that enough? Do you still want more money?
- xi. Director Clark: We are just a little disheartened because we thought we would have whatever remainder and I wish that we could still have that.
- xii. President Coulter: How much do you expect to have on the committee discretionary fund?
- xiii. Director Clark: Whatever we didn't use for WUFest

- xiv. Senator Hastings: I think it is always possible for the committee to request funds form the reserves!
- xv. Chairperson Ross: The issue with that is that when we would pull from reserves, you do have to talk in front of senate, but no other committee would have to get this same level of senate approval. It feels like an extra hurdle.
- xvi. Director Clark: Chairperson Ross said that very well. I think that it is still important to keep all of the committees the same and I wish that we could get this funding back.
- xvii. Senator Lloyd: What is the number that the committee would like to request.
- xviii. Director Clark: I wish that we would put back exactly what we pulled out of the committee.
  - xix. Senator Lloyd: When we get to the bill, we need to add a line item.
  - xx. Director Newfer: We only have to change the documents, so we just have to change that, not the bill.
  - xxi. President Coulter: I am ok with that.
- xxii. Chairperson Brungardt: We created this committee, so maybe we should invest in it!
- xxiii. Senator Cervantes-Rodriguez: Every other committee has a discretionary fund and we don't, why is that?
  - 1. Coulter: This is because you have event line items? We have never had a Special Events Committee! We didn't know!
- xxiv. Senator Barbery: They can't have any other events other than the one that there are line items for? The funding is only for those events, so how do they have the ability to do anything else? Do you not see this as hindering the committee?
  - 1. Coulter: Yes, and no. Seeing that the committee is new, we did not have the faith in their ability to do more.
- xxv. Senator Bottom: I am a little confused on what the issue is and why we cannot use our money to do events?
  - 1. Director Ginn: You can still use this line item to do other things, but the gov says it's a little weird. Anything that we do has to be under the correct line item event. Rather than a committee of its own, this should just be a

supporting committee and we didn't expect them to be like CCA or SAB.

- xxvi. Director Clark: We were operating under 6,000 for WU Fest and we wanted to keep the amount that we had saved, instead of giving that money to other people. The Hoco budget went down, can you explain why?
  - 1. That was a conversation that we had with Dr. G.
- xxvii. Senator Lloyd: The Special Events committee wants 500\$???
  - 1. Is everybody okay with giving the committee \$3,000?
- xxviii. Chairperson Brungardt: This will be a new line item under the committee?
  - 1. Yes, we are pulling this money out of the buffer instead of out of the greants.
  - xxix. Senator Cervantes-Rodriguez: Do discretionary funds change every year?
    - 1. No. It depends on the administration. The next admin will add or take away based on our budget.
  - xxx. Moved out of the PF.

#### VIII. New Business II:

- a. SB #100: Open Floor Act
  - i. Senator Lloyd: The current bylaws do not have a specific process for submitting bills and resolutions, which has caused some problems with submitting legislation in the past.
  - ii. Chairperson Brungardt: How much of a burden will this place on LRD Newfer?
    - 1. It's manageable! I am also interested in doing this
  - iii. Chairperson Brungardt: Does this section mean that we just see every bill regardless of whether we have a committee see it or not? Could a funding thing go through without being seen by allocations? How do we stop this?
    - 1. The point of the direct ask would be so that it is not up to the discretion of any one member, so I would be okay with it changing if we needed to modify it.
  - iv. Chairperson Brungardt: I think that this could be risky for issues with the funding policy
    - 1. If the bill has anything to do with funding, this would be up to the discretion of the Allocations Chair?

- v. Senator Lloyd: Amend subsection 5.4 to add "if any bill or resolution deals with funding, it is up to the discretion of the Allocations Chairperson"
  - 1. Amendment is accepted
- vi. Senator Yucesan: One of the points was that every bill gets to be heard?
  - 1. There was one time where a resolution went though IA for practicality reasons, which doesn't make a lot of sense. If we cannot get a relevant body to review it, it should just be seen by all of senate.
- vii. Bill passed.
- b. SB #101: Election Policy Reformation Recommendation
  - i. Senator Lloyd: This is from the ad hoc committee and it makes amendments and one of the biggest changes is from 5 week elections to 4 weeks to represent what is said in the rest of our governing documents. This also puts accountability on campaigns and their teams and makes it more of a free process.
  - ii. Chairperson Brungardt: How do we know who is on what campaign team and is there a formal structure to keep track of that
    - 1. The cabinet member tasked with campaigns will be made aware of who all is on the campaign team and will be disclosed and keep track of their behaviors.
  - iii. Chairperson Brungardt: Is there a timeline for that?
    - 1. Director Newfer: If they are working on your campaign and they are not disclosed, this is an immediate violation and would be made known.
  - iv. Bill passed.
- c. SB#102: Updated Budget Proposal
  - i. Chairperson Ross: I would like to make an amendment to add a special events line item to make sure that we add \$3,000 to the special events line item.
    - 1. Director Newfer: We don't need to make that change on the document
  - ii. President Coulter: We are going to be pulling money from our buffer, not from grants.
  - iii. Senator Lloyd: Can we pull up the document so that we can see the active changes.

- iv. Director Newfer: We can just amend the document to say that changes should be made based on the relevant documents and the meeting minutes.

SENATE BILL <u>2025-26 #100</u>

TITLE: Open Floor Act

ORIGINATOR: Senator Lloyd SPONSOR: Senator Lloyd

STATUS: Internal Affairs Committee – Pending

WHEREAS: Transparency and fairness in the legislative process are foundational to the mission and integrity of the Washburn Student Government Association (WSGA); and

WHEREAS: The current structure allows committee chairs or presiding officers to withhold legislation from being heard, which may unintentionally prevent student concerns and initiatives from receiving consideration by the Senate; and

WHEREAS: Ensuring that all formally submitted legislation receives a hearing promotes accountability, representation, and efficiency within WSGA; and

WHEREAS: The WSGA Senate desires to uphold its commitment to openness, responsiveness, and active student participation in governance.

THEREFORE, BE IT ENACTED BY THE WSGA SENATE:

SECTION ONE: Article I of the WSGA By-Laws shall be amended by adding the following new Section 5: Legislative Hearing Requirements

Section 5 – Legislative Hearing Requirements

Subsection 5.1: Purpose

The purpose of this policy is to ensure that all legislation introduced by members of the Washburn Student Government Association (WSGA) Senate is given a fair and timely opportunity to be heard, regardless of the discretion of any single officer or committee chair.

Subsection 5.2: Definitions

For the purposes of this policy:

"Hearing" shall refer to the placement of a bill or resolution on a committee or Senate agenda for discussion and/or vote.

"Submission" shall mean the formal delivery of a bill to the Legislative Director, Vice President, or any Standing Committee Chair.

Subsection 5.3. Automatic Hearing Provision

Any submission of a bill or resolution shall be referred to a Standing Committee at the discretion of the Legislative Research Director for a guaranteed hearing.

Any submission of a bill or resolution shall be guaranteed a hearing under the following timeline:

- a. Within two (2) regular meetings of the committee to which it is referred
- b. Within one (1) Full Senate meeting following committee inaction.

If a committee fails to schedule the legislation within this timeframe, the Parliamentarian shall automatically place the item on the next Full Senate agenda as Unreported Business.

A majority vote of the Senate may compel the inclusion of any legislation on the next agenda as Unreported Business.

Subsection 5.4. Author's Privilege to Request Direct Hearing

Any bill sponsor may, at the time of submission, request a Direct Senate Hearing. Upon hearing such request, the legislation shall be placed on the next Full Senate agenda as Unreported Business.

Subsection 5.5. Transparency and Tracking

The Legislative Research Director shall maintain a publicly accessible Legislation Tracking Log listing the title, number, originator, sponsor, submission date, committee assignment, and current status of all legislation.

Committee Chairs must update this log within forty-eight (48) hours of receiving or acting upon legislation.

Subsection 5.6. Enforcement and Accountability

Failure to comply with this section may be referred to the Internal Affairs Committee for review and recommendation as mis / mal / or nonfeasance.

SECTION TWO: This legislation shall become effective immediately upon passage by the WSGA Senate by a 2/3<sup>rd</sup> majority, subject to the veto power of the WSGA President as outlined in the WSGA Constitution.



TITLE: Election Policy Reformation Recommendation ORIGINATOR: Election Policy Ad Hoc Committee SPONSOR: Senator Hinds, Senator Stevens, Senator Lloyd STATUS: Election Policy Ad Hoc Committee – Pending

WHEREAS, disparities in access to voting resources, information, and candidate outreach have created barriers for full student participation in Washburn Student Government (WSGA) elections; and

WHEREAS, the Washburn Student Government Association is responsible for facilitating fair, transparent, and inclusive elections that reflect the voices of all students; and

WHEREAS, increasing transparency and accessibility in the election process will foster greater trust in student government and encourage broader civic engagement; and

WHEREAS, the WSGA Constitution and Election Policy grant the Senate authority to revise election procedures and implement reforms that promote equity and student engagement.

# THEREFORE, BE IT RECOMMENDED BY THE ELECTION POLICY AD HOC COMMITTEE:

SECTION ONE: Election Policy Chapter Two Amendments

- **Section One** shall be amended to state: The election campaign shall begin four weeks before the first day of the election and candidates may post campaign materials any time after that day
- **Section Three** shall be amended to state: The Budget Director will be charged with purchasing all campaign materials for campaigns so long as they are approved by the election board. In the event the Budget Director is running in the election, the cabinet member charged with overseeing elections shall collaborate with Student Life to facilitate the purchase of campaign materials.
- **Subsection 4.3** shall be amended to state: The Cabinet member charged with overseeing the election shall provide the location to submit the campaign slogan to the university.
- Section Six shall be added, named Ballot Content Regulations, and shall state: The platform the ballot for all student government elections shall be decided by the advisor for student government and the cabinet member charged with overseeing elections. The Ballot shall state the name of each Senator or ticket in the order of which their election packet was submitted.
- **Subsection 6.1** shall be added, named permitted content, and shall state: A bulleted list, each comprising of one statement, limited to 30 words, shall be allowed on the ballot. A maximum of 6 bullets shall be allowed.
- **Subsection 6.2** shall be added, named prohibited content, and shall state: On the bulleted list no wording that is obscene, racist, sexist, or libelous towards candidates or persons shall be allowed to be on the ballot. The cabinet member charged with overseeing elections shall make an initial ruling and if the candidates disagree they may appeal to the Election Board.

No photos shall be allowed on the ballot.

SECTION TWO: Chapter Three Amendments

• Section One shall be amended to say: Campaign Materials or behaviors made by candidates or their campaign team that are obscene, racist, sexist, or libelous towards candidates or persons are unacceptable and shall be punished by the board.

SECTION TWO: This recommendation shall be forwarded to the cabinet member charged with overseeing the Fall 2025 election.
