 - ii. Chairperson Brungardt: Allocations has been doing a lot of work to allocate money to grants, and we are running out of funding for this quickly. We would like to see \$30,000 pulled from reserves so that we can add budget to the student development grants.
 - 1. VP Durst: Do you want to explain why?
 - 2. Chairperson Brungardt: Yes, this will give us \$15,000 more to spend, because a bill from last year made it a requirement that the funding would be split equally between semesters. This would give us more to allocate this semester.
 - iii. Senator Hastings: We have over \$180,000 in reserves, and the value of this reserve decreases, so being able to spend this is very helpful.
 - iv. President Coulter: They are only ½ way through the money
 - v. Chairperson Brungardt: They are still operating off of the old budget, and a lot of things were tabled last week so that we can see the changes made and I don't think that this is necessary this week.
 - vi. Senator Bourell: I move to pull the money from reserves to add this to the Student Grant Budget

- vii. Senator Lloyd: This is a lot of money to spend on student grants. I would be more inclined to spend this on bigger projects and more than 1 student
- viii. Vice Chairperson McGill: this is not a small handful of students. There are a lot of grants that have many students represented under them. This is not a small thing, and to say that strips them of their meaning
 - ix. Senator Hastings: This does go to huge projects like the EcoBods pathway like we just saw.
 - x. Senator Anderson: Do we have updated numbers of how many people we have served with these grants? And have we thought about splitting up the student grants so that we have them on and off-campus?
 - 1. President Coulter: This is not split up because we were just handed last year's spreadsheet. We would be open to making this revision
 - xi. President Coulter: Do you want 30,000 for this semester only or 15,000 and 15,000?
 - 1. Chairperson Brungardt: Any monies would be automatically split in half. This happens through all of our processes. Other initiatives would be great, but we are seeing things right now that demonstrate an immediate need. We should serve as many as possible, as per our slogan.
- xii. Chairperson Ross: Just because we are pulling out that funding does not mean that we would use it all, so it could go back to Reserves. This is the literal epitome of "Students Serving Students"
- xiii. Senator Hastings: We have served many and plan to serve 4 more people next week
- xiv. Chairperson Brungardt: I amend the bill to add in the condition that changes can also be reflected in the meeting minutes.
 - 1. The amendment is passed.
 - 2. (Thank you all! I love taking minutes \bigcirc)
- xv. President Coulter: I will make the change, but this will make a lot of red on the spreadsheet, just because this is from reserves, not from the current student budget
