THEREFORE, BE IT ENACTED BY THE WSGA SENATE:

SECTION ONE: The Washburn Student Government Association shall allocate an amount not to exceed \$1,000.00 from the Student Organizations account to James Tanasyah for their APYE conference attendance fees.
