 - n. SB #155: Kinesiology Club – Conference Fees
 - i. Requesting \$1500 to send students to their central state conference. The bill has passed!
 - o. SB #156: French Club – Study Abroad
 - i. Tabled for 1 week.
- IX. Public Forum I:
- a. REFORM Act (SB #154) First Viewing: Legislative Research Director Newfer
 - i. He stole paper from student media.
 - a. Brungardt: Point of Information, is it available online?
 - b. Newfer: It will be put online tonight, but it is not being voted on tonight.
 - ii. This is the bill! These documents will take the place of the old documents. There's 2 main district changes. The first is that if there is a redundancy, that is changed. Such as the ability to make committees. The actual policy change is that committee assignments are appointed by the speaker and not president. Parliamentarian is also elected instead

of chosen by the president. Elections policy cannot be gotten rid of as it is in other documents as well. There is no removal of powers; these powers are stated in other by-laws. Budget duties are changing. Senate has power of the purse. Lots of removing other documents. Most changes were made by Director Newfer or Senator Lloyd. Lots of correcting the confusing terms used. Getting rid of the level of participation. We are expected to be here and do our job. We already do many of these things, but he has updated them to match how we function. Letting senate put something on the ballot for others to vote on.

a. Parliamentary Sharp: There is a discrepancy in the wording "51%"

b. Newfer: Is going to change it. Many people helped him get the right wording.

iii. Vice president Clark: We are just showing it today as it must be heard twice then get a 2/3 majority vote.

iv. Senator Artzer: Why the changes to the movement of power from president to speaker?

a. Newfer: In order for the branches to be sovereign to themselves. We shouldn't be telling people how to do their jobs.

b. Senator Smith: Internal Affairs is directly related to fundings being passed. If we are removing or amending why does IA get to review it.

c. Newfer: There isn't any other body to be there for review. It is important for there to be something to uphold it. IA is best as it is used for disciplinary actions

d. Senator Smith: He doesn't think that anything will change, and questions whether IA will review it correctly.

e. Newfer: Not every single bill will be brought.

f. Senator Smith: Nothing will happen if they think it

is unconstitutional.

g. Newfer: The constitution is a superseding document. If it is unconstitutional, it will be rescinded. If someone came in to destroy WSGA, it would not be valid if it was passed in a week. If they are unconstitutional, it should be left up to the student body. He did not want to create a judiciary branch.

h. Senator Smith: It doesn't involve everyone who is in senate. Suggests if it's unconstitutional then bring it to senate.

i. Director Newfer: Everything has to be passed by senate.

v. Vice President Clark: Wants to look at the other document and extend time.

a. Chairperson Ross: Motions to extend time. Time is extended by 20 minutes.

vi. If the veto is overwritten, any WSGA senator can move to overturn the veto. The speaker is in charge of nominating Chair and Vice Chairpeople. Parliamentarian is chosen by appointment.

a. Senator Smith: Will it follow the procedure of nominations.

b. Newfer: It is copied and pasted, so it is the same.

c. Senator Smith: Thinks 2.3 is redundant.

d. Newfer: It was not in the original draft. Doesn't see it as negative.

e. Senator Smith: Doesn't want it to be redundant.

vii. Chairperson Ross: Explains that he believes the Vice Chairperson is not chosen by the Speaker or the President. Usually, it is appointed by the committee.

a. Chairperson Brungardt: Point of Order – Vice Chairpeople are appointed by the president.

- b. Vice President Clark: The president lets the committee chose the Vice Chairperson, but she does not have to let that happen.

viii. Chairperson Brungardt: Wants to know about the discussions with others that went into the changes of this bill. Wants it run by more people first.

- a. He initially talked to the President, Vice President, and sponsor as well as Chairperson Ross. He did this to make sure others agreed with his changes. This bill can be delayed if it's not ready for a vote. He endorsed every edit in this document and asks if it should be brought back later.

- b. Chairperson Brungardt: Since we are seeing it for the first time, and a few people are seeing some discrepancies and are wanting to discuss them. She asks Parliamentarian how it would look to push this bill back. Also asks if the reason that Senator Lloyd helped make so many edits is because he is the sponsor of the bill.

- c. Director Newfer: Yes.

- d. Chairperson Brungardt: In what capacity does a senator usually assist with by-law changes.

- e. Director Newfer: The introduced some last year without a senator sponsor which is incorrect. He changed it this year to be a senator's sponsor and not an administrative sponsor. Everyone was doing it wrong before, but everything is still valid. This is how it will happen from now on.

ix. Senator Anderson: Thinks the changes are really great. From her point of view the changes for the speaker and having senate in more control is very good. Any changes that need to be made can be made quickly.

- a. Director Newfer: Appreciates her response. Do they have any more suggestions?

b. Chairperson Ross: Thinks the same as Senator Anderson. Believes, we can address things here to make things go faster.

x. Vice Chairperson McGill: Yields her time to Senator Smith.

a. Senator Smith: This is a lot of new responsibilities so would people need a higher compensation?

b. Director Newfer: This doesn't go into effect until the next administration, so the new speaker would be aware. This isn't taking away power.

c. Senator Smith: He thinks the parliamentarian should be able to determine unconstitutionality.

d. Director Newfer: That is currently within his power. If something is missed by him and passed in Senate and it is unconstitutional, then it will result in giving unlimited power to one person.

e. Senator Smith: Relating us back to the U.S. Senate. Agrees with Kendall that there should be a longer conversation.

f. Senator Bourell: Thinks we need time to vote on this bill as not everyone has enough time to review these changes. Wants more meaningful conversations after people can look it over.

g. Director Newfer: He is not in charge of that and explains it has gone through IA and is just here to explain it. Amendments can be made to his documents.

h. Parliamentarian Sharp: Point of Clarification – This is just a presentation and will not be voted on until next week.

i. Director Newfer: Explains we might need more than a week.

xi. Director Redington: Point of Information – If changes are made later, would it have to go through IA again?

- a. Parliamentarian Sharp: Yes, as it would be a different bill.
- b. Senator Lloyd: Point of Clarification – The bill just says the attached documents, so it doesn't change the bill itself, so it would not have to go through IA again.
- c. Director Newfer: It would only be an amendment. Not a new bill. He says we could deny the bill so it can be changed later.

xii. Chairperson Ross: Disagrees with creating a new committee for these reasons as senators can use their office hours to go talk to Caleb Newfer and make changes if needed.

- a. Senator Anderson: Agrees with Chairperson Ross. If there are specific conversations to be had, senators have a week to do so.

xiii. Director Newfer: He wants to hear everybody's ideas.

xiv. Parliamentarian Sharp: That is time for the public forum

xv. Senator Mcfan: Motions to extend the public forum by 15 minutes.

- a. Motion is seconded
 - i. Division
 - ii. Public forum is not extended
- b. Motion to close public forum
 - i. Motion has passed!

X. New Business II:

a. SB #152: Funding Request Attendance Modification

- i. Presented by Chairperson Brungardt: A big problem is we are asking students to stay unreasonably long. This is a attendance policy to change senate rules to change how it goes through legislation. This is mainly for funding request bills. Any bill that is given favorable status; the representative would not have to come to senate.

- a. Anderson: So basically, they come here, go to allocations, then

they can leave.

b. Brungardt: Correct.

ii. Bourell: Would the bill still be presented to Senate?

iii. Brungardt: Yes, they just do not come to senate. It also allows the chairperson to speak upon the bill that has been given favorable status.

iv. McGill: So, you just explain, and then we vote.

a. Chairperson Brungardt: Only if there aren't any questions.

b. Senator McGill: Bill, then vote?

c. Chairperson Brungardt: Yes, if there is no discussion then we move to a vote.

d. Senator McGill: Then what is the point of it coming to senate?

e. Chairperson Brungardt: Should bills be coming to Senate? We need to figure that out. Funding requests are required to be bills. This saves them time before we can properly figure things out.

f. Senator Smith: Is it in there that you can speak about things

g. Chairperson Brungardt: Yes

h. Senator Smith: Can we just make them fill out funding requests? We can change the funding policy, but he doesn't think we should have to discuss bills.

v. Parliamentarian Sharp: This is just a continuation of Senator Lloyds bill

a. Senator Lloyd: Even though this is a step back from his bill, it is still a step forward. He thinks we should pass the bill.

b. Senator Artzer: Would the representatives still come and present?

c. Chairperson Brungardt: Yes

vi. Senator Bourell: It's important for there to be transparency. We like seeing faces and we want to know who to get connected to, and this gets rid of that. It's not fun to be here when you are on the outside, but it eliminates the point of us being here. How would we then get connected to. It's a sense of community and that is why we are here

vii. Vice Chairperson McGill: If we pass this tonight, can we also have senator smith introduce something that also changes it later down the road.

a. Vice President Clark: Yes, then we can build or undo any of this

b. Vice Chairperson McGill: Then we should do this. We all agree

that this is good. Yields time to President Coulter

- viii. Chairperson Brungardt: We are here to give people money, and we oversee it. It's a good thing to know where our money is going.
- ix. Vice Chairperson Motes: Gives time to Newfer
- x. Legislative Director Newfer: He supports this bill as it is a great improvement to our system. DO not interrupt people PLEASE.
- xi. Senator Newfeld: Really likes this bill and thinks that people choose allocations for a reason. She proposes that the representatives can come if they want, but it's not required.
- xii. Motion and second to close debate. Division. Bill is Passed.
- b. SB #153: Canva Equity Act
 - i. Presented by Senator Lloyd: Student organizations heavily use visual tools to advertise events and recruit members, and Canva Pro would provide organizations with these tools. Many student organizations lack funding for this software. The estimated cost is 5,000. This bill allows student organizations to submit a receipt for Canva Pro and get reimbursement.
 - ii. Parliamentarian Sharp: Clarifying whether 5,000 is for 30 organizations. Checking that they would have to submit a receipt to get the money back and that it is not a part of OSID.
 - a. Senator Lloyd: They first have to be a registered organization and go to the budget director to get the money back.
 - iii. Parliamentarian Sharp: Does this come from the allocated 5,000.
 - a. Senator Lloyd: Yes
 - iv. Vice Chairperson McGill: Wants to address that not many people have requested Canva before so why would there be a need for organizations to have Canva Pro. Making them buy it and then come back to get reimbursed could lead to an organization being out that money. It's better for them to go through allocations for them to approve.
 - v. Chairperson Brungardt: Asking Senator Lloyd about how he decided on picking Canva Pro.
 - a. Senator Lloyd: A lot of organizations already use Canva Pro, so it would be very accessible as well as it is cheaper than other resources.
 - b. Chairperson Brungardt: Explains that all Washburn students already have access to all Adobe resources. So why would there be a need for Canva as well. This would bypass Senate.

- c. Senator Lloyd: He did not know Washburn had that and thinks that should be advertised. Although Canva is still very accessible. And this would not bypass Senate as Senate would be voting on the bill to give it to the organizations.
- vi. Senator Artzer: Yields time to Director Kerney.
- vii. Director Kerney: What makes this different from a regular funding policy. It is stated that they might not have the funds themselves, but they would still have to pay out of pocket before they are reimbursed.
 - a. Senator Lloyd: It is meant for new student organizations so they can quickly grow their student numbers.
 - b. Director Kerney: What do we do if an organization gets Canva Pro and then stops using it.
 - c. Senator Lloyd: They will have it for the year and if they don't use it, they won't get it again next year.
 - d. Senator Artzer: Reclaims Time. What if they only use it once.
 - e. Senator Lloyd: The original intent was a month-by-month basis, but others wanted it to be a full year.
- viii. Senator Smith: Thinks this bypasses senate as it doesn't go through allocations. Allocations is about budget and going directly to Budget Director Ginn. Then it is not voted on. Other marketing platforms should be advertised to students.
- ix. Chairperson Ross: Is this adding a line item to our budget?
 - a. Senator Lloyd: It would be coming out of the allocated student organization fund.
 - b. Chairperson Ross: They buy it and go to the budget director?
 - c. Senator Lloyd: Correct.
- x. Senator Anderson: Agrees that organizations don't need Canva Pro. We have a process for organizations to ask for tools. In the WSGA office, you have access to Canva if you come and ask for it. Yields time to Director Hammes.
 - a. Director Hammes: Any organization can ask Director Hammes for help. She has a lot of time to help others if they need it. She thinks the bill is misleading but doesn't think it is bad. We have more than 30 clubs so there is not enough for every organization.
- xi. Senator Bourell: Organization leaders don't have problems going in for funding requests. Although they have had problems with people using Canva Pro for personal purposes. Doesn't see the benefit of this

bill.

- xii. Vice Chairperson Motes: Yields time to Director Newfer.
 - a. Director Newfer: This is not in violation of the sovereignty of Senate. The power of the purse is given to Senate. Shows the by-laws to explain senate supersedes the allocation committee. If Senate allocated money which doesn't send it to allocations, it is not a violation of the constitution.
 - b. Vice Chairperson Motes: Reclaims time. Motions to previous question. Motion is seconded.
- xiii. Senator Smith: Point of information – does active discussion supersede previous question.
 - a. Parliamentarian Sharp: There is no debate.
- xiv. Motion Passes
- xv. The bill fails.

WHEREAS, the Washburn Student Government Association (WSGA) currently utilizes a legislative process which is through, but not always considerate of the student body's time; and

WHEREAS, the current WSGA Funding Policy requires student or Student Organization representatives to attend Full Senate Meetings to speak on their funding requests, even after they have been given Favorable status by the Allocations Committee; and

WHEREAS, the WSGA has the authority to create legislative procedures that protect the integrity of our institution while also remaining committed to transparency and accessibility in the student body's ability to request Student Activity Fee funds.

THEREFORE, BE IT ENACTED BY THE WSGA SENATE:

SECTION ONE: The purpose of this legislation is to amend the attendance requirements in which a student or a Student Organization representative must remain present to speak on their request. This change creates a process which only requires the attendance of students or Student Organization representatives if their funding request bills are given Unfavorable or Neutral status in committee.

SECTION TWO: The following revisions to the Funding Policy will be adopted as amendments to Chapter 4. of the policy:

- ~~Funding Request Paperwork is~~ Funding requests are completed and submitted to the WSGA Budget Director two weeks prior to the date of the event the goods are being purchased for. Requests should always include but are not limited to: clearly stated details about the subject of the request, a spending breakdown, and the dates and times pertinent to the request.
- b. The Budget Director shall immediately deliver the paperwork to the Allocations Committee Chairperson, who will present it in the form of a bill to the next Allocations Committee and Full Senate Meetings, unless consent is granted by the requesting organization to delay the process.
- c. ~~The legislation will then proceed through the standard legislative process as outlined in the Standing Senate Rules.~~ The legislation will be required to proceed through the process outlined below:

 - i. The requesting student or a representative from the requesting organization will be required to attend to speak on the bill in The Allocations Committee and Full Senate Meeting immediately following their request submission. This

- student or organization representative cannot be a sworn-in member of the WSGA.
- ii. The Committee will then give status to the funding requests in bill form. The Committee may grant one of three statuses: Favorable, Unfavorable, or Neutral.
 - a. To give any status to a funding request bill, a 2/3 majority is required.
 - b. The requesting student or organization representative will not be required to speak on their request in the Full Senate meeting if their bill is given Favorable status by the Allocations Committee.
 - i. Any requesting student or organization representative is permitted to speak on their request in Full Senate Meetings, regardless of the status given to their funding request bill.
 - iii. After a funding request bill has been given status in the Allocations Committee, it will be presented in the Full Senate meeting directly following its consideration in committee.
 - iv. For discussion in Full Senate relating to funding requests given Favorable status in committee, the Chairperson of the Allocations Committee may speak on behalf of the requesting student or organization.

SECTION THREE: Responsibility

1. Within two weeks of this bill's passage by the WSGA Senate:
 - a. The Legislative Research Director will ensure that the Funding Policy is updated and redistributed.
 - b. The Budget Director will inform all requesting organizations of this change throughout the Spring 2026 semester and will ensure that both the Student Grant request form and the Student Organization request form both reflect these changes.
 - c. The Communications & Marketing director will inform the student body of these changes through the applicable communications mediums. This includes but is not limited to: social media posts, the blinky board, and direct communications with Student Organization representatives.

SECTION FOUR: This legislation shall become effective upon passage by the WSGA Senate, subject to the veto power of the WSGA President.



SENATE BILL 2025-26 #153

TITLE: Canva Equity Act

ORIGINATOR: Senator Lloyd

SPONSOR: Senator Lloyd

STATUS: Allocations Committee - Pending

WHEREAS, the Washburn Student Government Association (WSGA) is charged with representing the interests of the student body and supporting student organizations; and

WHEREAS, student organizations rely heavily on visual communication tools to advertise events, recruit members, and engage the Washburn University community; and

WHEREAS, Canva Pro provides professional design tools, templates, collaboration features, and accessibility options that enhance the quality and efficiency of student organization materials; and

WHEREAS, many student organizations lack the financial resources to independently purchase professional design software; and

WHEREAS, providing universal access to Canva Pro would promote equity among student organizations by ensuring equal access to high-quality design resources

WHEREAS, the estimated cost of this bill is \$5,000, the cost of a singular organization.

THEREFORE, BE IT ENACTED BY THE WSGA SENATE:

SECTION ONE: AUTHORIZATION and ADMINISTRATION

1. Every registered student organization shall be allowed to be reimbursed for one Canva subscription.
2. Each organization shall be allowed to have one yearly Canva Pro subscription per academic year. Organizations can turn in a receipt for the Canva subscription, and it shall be reimbursed into their agency account.
3. This reimbursement shall come out of the organizations allocated amount in the Funding Policy.
4. The Budget Director shall notify the allocations committee of every organization that uses this program.

SECTION TWO: Responsibility

2. The Budget Director shall make sure that each organization only gets one reimbursement for Canva per month.
3. The Budget Director will inform all requesting organizations of this change throughout the Spring 2026 semester.
4. The Communications & Marketing director will work with the Budget Director to add this information to the WSGA website.

SECTION FOUR: This legislation shall become effective upon passage by the WSGA Senate, subject to the veto power of the WSGA President.
